### A BILL INTITULED

AN ACT to reserve and vest Land as an Endowment Title.  
for the Bluff Harbour.

**B**E IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :—

1. The Short Title of this Act shall be “The Bluff Harbour Short Title.  
Endowment Act, 1878.”

5 2. The lands described in the Schedule hereto are hereby reserved, Lands described in  
Schedule vested in  
Bluff Harbour  
Board.  
and shall, from and after the passing of this Act, vest in the Bluff Harbour Board, as constituted by “The Bluff Harbour Board Act, 1876,” and shall be held by the said Board upon the like trusts, with the powers and for the purposes set opposite to the land in the  
10 Schedule to this Act.

### SCHEDULE.

Schedule.

ALL that parcel of land situated in the Southland division of the Provincial District of Otago, containing by admeasurement ten (10) acres, more or less, being Section twenty-five (25), Block one (I.), Campbelltown Hundred. Bounded as follows: Towards the North-west by Section 6 of said Block I., one thousand (1000) links; and towards the North-east by road and Sections 6 and 5 of said Block I., one thousand (1000) links; towards the South-east by Section 5, one thousand (1000) links; and towards the South-west by Sections 5 and 6, one thousand (1000) links: save and excepting a right of road 100 links wide, in, through, or over the said parcel of land. For a signal station in connection with Bluff Harbour.

All that parcel of land in the Southland division of the Provincial District of Otago, containing by admeasurement three (3) acres one (1) rood, more or less, being Sections 3, 4, 5, 6, 7, 8, 9, 15, 16, 17, 18, 19, and 20, Block XIX., Town of Campbelltown. Bounded as follows: Towards the North by Bann Street, seven hundred (700) links; towards the East by Sections 10 and 11 of said block, two hundred and fifty

(250) links; towards the South by Section 14 of said block, one hundred (100) links; again towards the East by Section 14 of said block, two hundred and fifty (250) links; again towards the South by Lagan Street, six hundred (600) links; and towards the West by Sections 21, 22, 1, and 2 of said block, five hundred (500) links. For a site for a reservoir for the supply of water to the shipping at the Bluff.

All that parcel of land situated in the above-mentioned Town of Campbelltown, containing by admeasurement two (2) roods and four (4) poles, more or less, being Sections 4 and 5, Block XII., of said town. Bounded towards the North by Sections 1, 6, and 8 of said Block, two hundred and sixty-eight (268) links; towards the South-east by Section 7, Block I., Campbelltown Hundred, two hundred and seventy-six (276) links; towards the South by Foyle Street, one hundred and fifty-one (151) links; and towards the West by Lee Street, two hundred and fifty (250) links. For offices for the Bluff Harbour Board.

All that parcel of land in the above-mentioned Town of Campbelltown, containing by admeasurement one (1) acre one (1) rood and fifteen (15) poles, more or less, being part of public reserve in the Town of Campbelltown. Bounded as follows: Towards the North by Lagan Street, one thousand three hundred and fifty-three (1353) links; towards the South-east by public road, one thousand three hundred and sixty-eight (1368) links; and towards the West by other part of the said reserve, one hundred and ninety-nine (199) links. For a site for a reservoir for the supply of water to the shipping at the Bluff.

All that parcel of land situated in the Southland division of the Provincial District of Otago, containing by admeasurement two (2) roods, more or less, being Sections twenty-one (21) and twenty-two (22), Block sixty-three (LXIII.), Town of Invercargill. Bounded on the North by Sections 1 and 2 of the same block, two hundred (200) links; on the East by Section 20 of the same block, two hundred and fifty (250) links; on the South by Esk Street, two hundred (200) links; and on the West by Deveron Street, two hundred and fifty (250) links. For offices for use of Bluff Harbour Board.

All that parcel of land situated in the Southland division of the Provincial District of Otago, containing by admeasurement four (4) acres and eighteen (18) poles, more or less, being Section twenty-six (26), Block one (I.), Campbelltown Hundred. Bounded as follows: On the North, East, and South by Foveaux Strait; and on the West by road reserves, and by Section 1 of the said Block I., one thousand four hundred (1400) links. For a pilot station in connection with Bluff Harbour.
