## A BILL INTITULED

An Act to regulate the Making and Sale of Bread and Title. to prevent the Adulteration thereof and of Meal and Flour.

DE IT ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows—

The several sorts of bread which shall be made for sale or sold 5 or exposed for sale shall always be well made and in their several and respective degrees according to the quality of the meal or flour whereof the same ought to be made and no alum or mixture in which alum shall be an ingredient or any other mixture or ingredient whatsoever other than and except as hereinbefore mentioned shall be 10 put into or in anywise used in making bread for sale under any color or pretence whatsoever And every person who shall knowingly offend in the premises shall on conviction of every such offence forfeit and pay any sum not exceeding ten pounds nor less than forty shillings.

21.
