A BILL INTITULED

AN ACT to amend "The Borough of Brunner Enabling Act, 1889." Title.

WHEREAS by section thirteen of "The Borough of Brunner Enabling Act, 1889," it was provided that the said Borough of Brunner Preamble.  
5 (hereinafter referred to as "the said borough") should have power to raise a loan under "The Municipal Corporations Act, 1886," "The Local Bodies' Loans Act, 1886," and "The Borough of Brunner Enabling Act, 1889," to pay to the Grey County Council the sum of one thousand five hundred pounds awarded to it by the  
10 Auditor and Controller-General for the Colony of New Zealand: And whereas the said borough has applied to the Colonial Treasurer of the Colony of New Zealand to lend to it the said sum of one thousand five hundred pounds: And whereas the said Colonial Treasurer has refused to make such loan owing to the omission in the said  
15 "Borough of Brunner Enabling Act, 1889," of the incorporation therewith of "The Government Loans to Local Bodies Act, 1886," and of any authority to make such loan: And whereas it is expedient that the said borough should have power to raise the said loan under  
"The Government Loans to Local Bodies Act, 1886:"

20 BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Borough of Brunner Enabling Act 1889 Amendment Act, 1890." It shall be deemed to Short Title.  
25 be incorporated with "The Borough of Brunner Enabling Act, 1889," hereinafter referred to as "the said Act."

2. The said Act is hereby amended as follows: In section Amendment of Act of 1889.  
thirteen of the said Act the words "The Government Loans to Local Bodies Act, 1886," are hereby inserted after the words "The Muni-

cipal Corporations Act, 1886," wherever the same occur in the said section.

3. "The Government Loans to Local Bodies Act, 1886," shall be altered as follows :—

In section twenty-five of "The Government Loans to Local Bodies Act, 1886," the words therein appearing, "Provided that not more than eight hundred pounds shall be lent in any one year to any one borough," shall, for the purposes of the said Act and this Act, be omitted from the said section twenty-five. 5

Loan may be  
granted by Colonial  
Treasurer.

4. The Colonial Treasurer may grant the said loan of one thousand five hundred pounds to the said borough, notwithstanding that the purpose for which the said loan is required is not one of the purposes for which a Borough Council or other local authority is empowered by "The Government Loans to Local Bodies Act, 1886," to borrow and raise money by way of loan under the now-reciting Act 15 for public works, and therein defined.
