A BILL INTITULED

AN ACT for the Transfer of the Native Reserve at Riverton, in the Provincial District of Otago, New Zealand, to the Corporation of the Borough of Riverton: Title.

5 WHEREAS it is desirable that the parcels of land described in the Schedule hereto, and known as the Riverton Native Reserve, should be vested in the Corporation of the Borough of Riverton: Preamble.

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

10 1. The Short Title of this Act is "The Borough of Riverton Endowment Act, 1900." Short Title.

15 2. On the passing of this Act the lands described in the Schedule hereto shall cease to be a Native reserve, and shall be and are hereby vested in the Corporation of the Borough of Riverton as an endowment for the benefit of the said Borough of Riverton without any grant, transfer, or conveyance. Native reserve at Riverton vested in Corporation of Riverton.

20 3. The Corporation of the Borough of Riverton may use, subdivide, lease, and otherwise deal with the said lands in accordance with the provisions of "The Municipal Corporations Act, 1886," and the amendments thereof. Corporation may deal with lands.
