## A BILL INTITULED

AN ACT to amend "The Census Act, 1858," and Title. other Acts amending the same.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :---

1. The Short Title of this Act shall be "The Census Acts Short Title. Amendment Act, 1870.<sup>3</sup>

on which the general census provided for by "The Census Act, 1858," shall be taken, and this notwithstanding that such additional account has already been taken in this present year, and in the event of the said additional account being taken again in this present year, in accordance with the provisions contained in this section, then no addition account **5** shall be taken under "The Census Acts Amendment Act, 1867," in and for the year one thousand eight hundred and seventy-one, but the next account shall be taken in the year one thousand eight hundred and seventy-two; and "The Census Acts Amendment Act, 1867," shall apply to such time or times, and the account to be then taken, as fully **10** as if such time or times had been specified in the fourth section of "The Census Acts Amendment Act, 1867."

4. In addition to the matters specified in the Schedule to "The Census Acts Amendment Act, 1867," information shall be obtained by the Enumerators and Sub-Enumerators at every general census 15 and by the Collectors at every account taken under the fourth section of "The Census Acts Amendment Act, 1867," with respect to the subjects comprised in the Schedule to this Act.

5. In any Form of Return in which the religious denomination of any person is to be filled in, the occupier or person in charge of 20 any dwelling-house, or other person whose duty it is to fill up such form, may, if the person whose religious denomination is to be filled in objects to state whether he belongs to any or what religious denomination, fill in the word "Objects," instead of the religious denomination of such person, and that shall be deemed a sufficient compliance with 25 the law.

6. The words "Extent of Land Fenced" shall be omitted from the Schedule to "The Census Acts Amendment Act, 1867," and the said Act and the Schedule thereto shall be construed and read as if the said words did not appear therein.
