A BILL INTITULED

An Act to validate certain agreements made by the Cambridge Borough Council

WHEREAS the Cambridge Borough Council resolved on the 5 29th day of November 1972 to sell the area of land first described in the Schedule hereto to Ronald James Pilkington for the sum of \$4,700 and an agreement for sale and purchase was signed on the 30th day of May 1973 and a transfer on the 30th day of October 1974: And whereas such resolution 10 was made without the consent of the Minister of Local Government as required under the Municipal Corporations Act 1954: And whereas on the 17th day of December 1975 the Cambridge Borough Council resolved to sell and on the 13th day of July 1976 the Cambridge Borough Council 15 executed an agreement for sale and purchase of the area of land secondly described in the Schedule hereto to Vincent Gerard O'Sullivan and Tui Rererangi O'Sullivan for the sum of \$14,500: And whereas such agreement was executed without the consent of the Minister of Local Government as re-20 quired under the Municipal Corporations Act 1954: And whereas the said Council wishes to validate the said sale:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Cambridge Borough Council (Sale of Land Validating) Act 1978.

2. Interpretation—In this Act, unless the context otherwise requires,—

"Borough" means the Borough of Cambridge:

- "Council" means the Cambridge Borough Council.
- 3. Validating agreements—(1) The actions of the Council 10 in resolving to sell the land described in the Schedule hereto without first having obtained the consent of the Minister of Local Government as required by section 150 of the Municipal Corporations Act 1954 are hereby validated.

(2) All money received by the Council pursuant to the said 15 agreements shall be deemed to have been lawfully paid to

and received by the Council.
