A BILL INTITULED

AN ACT to amend the Christchurch City Reserves Act, 1877. Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority
5 of the same, as follows:—

1. This Act may be cited as the Christchurch City Reserves Amendment Act, 1932-33, and shall be read together with and deemed part of the Christchurch City Reserves Act, 1877 (hereinafter referred to as the principal Act). Short Title.

2. The principal Act is hereby amended by omitting from the First Schedule thereto the third paragraph of the said Schedule, being the description of the piece of land mentioned in the Schedule hereto. Schedule to principal Act amended.

New.

2A. The principal Act is hereby amended by omitting from the First Schedule thereto the third paragraph of the said Schedule, and by substituting therefor the following:— Schedule to principal Act amended.

“All that piece of land situate on the west side of Cathedral Square, being part of the plot of land known as the Godley Statue Block, containing by admeasurement 20.2 perches, more or less:

bounded on the north by a line running $270^{\circ} 49'$, for a distance of 110.15 links; thence on the west by a line $179^{\circ} 42'$, for a distance of 114.74 links; and on the south by a line $89^{\circ} 58'$, for a distance of 111.71 links; thence on a bearing $358^{\circ} 54' 30''$, for a distance of 113.13 links, to the point of commencement, which point lies from a standard stone situated in Colombo Street immediately in front of the Anglican Cathedral in a northerly direction $359^{\circ} 49' 5''$, for a distance of 28.8 links; thence on a bearing $269^{\circ} 49' 5''$, for a distance of 156.4 links; thence on a bearing $359^{\circ} 49' 5''$, for a distance of 86.35 links; and finally on a bearing of $198^{\circ} 48'$, for a distance of 32.33 links: as the same is delineated on the plan deposited in the Head Office, Department of Lands and Survey, at Wellington, as No. 2622, and thereon edged red." 5

3. The said piece of land mentioned in the Schedule hereto is hereby vested in the Mayor, Councillors, and Citizens of the City of Christchurch, freed and discharged from all trusts, reservations, rights, or restrictions whatever. 15

Portion of Godley Statue Block declared to be street.

3A. The balance of the said plot known as the Godley Statue Block is hereby declared to be street.

Council to re-erect the Godley Statute on old site.

4. The Christchurch City Council shall within six months after the passing of this Act re-erect the statue of John Robert Godley on the land described in section *two A* hereof. 25

SCHEDULE.

ALL that plot of land situate on the west side of Cathedral Square, and known as the Godley Statue Block; and bounded on the east by the curved portion of Colombo Street, and on the north, south, and west by roads one chain wide. 30
