

## **CUSTOMS ORDERS CONFIRMATION BILL**

### **EXPLANATORY NOTE**

THE Bill confirms the Orders in Council specified in the Schedule, as required by section 131 of the Customs Act 1966. The Schedule, by virtue of section 5 of the Customs Amendment Act 1973, includes those orders made on or after 1 July 1974 but on or before 30 June 1975 and laid before Parliament.

Any Orders in Council made on or after 1 July 1975 are to be confirmed by an Act of Parliament before the close of the last day of the next ensuing session.

### A BILL INTITULED

#### **An Act to validate and confirm certain Orders in Council made under the authority of the Customs Act 1966**

WHEREAS by section 131 of the Customs Act 1966 (as  
5 amended by section 5 of the Customs Amendment Act 1973)  
it is provided that every Order in Council made under section  
124 of that Act on or after the 1st day of July in any calendar  
year and laid before Parliament shall expire on the close of  
10 the last day of the next ensuing session of Parliament in the  
following calendar year except so far as it is expressly validated  
or confirmed by an Act of Parliament passed during that  
session; and every Order in Council made under section 124  
of that Act on or before the 30th day of June in any calendar  
15 year and laid before Parliament shall expire on the close of  
the last day of that session except so far as it is expressly  
validated or confirmed by an Act of Parliament passed during  
that session: And whereas the Orders in Council specified in  
the Schedule to this Act have been made either wholly or  
20 partly under the authority of the said section 124 on or after  
the first day of July during the previous session but on or  
before the 30th day of June during the present session and  
have been laid before Parliament, and it is desirable to validate  
and confirm those orders:

25 **BE IT THEREFORE ENACTED** by the General Assembly of New  
Zealand in Parliament assembled, and by the authority of  
the same, as follows:

No. 57—1

**1. Short Title**—This Act may be cited as the Customs Orders Confirmation Act 1975.

**2. Orders in Council confirmed**—The Orders in Council specified in the Schedule to this Act are hereby declared to be valid and are hereby confirmed as required by section 131 of the Customs Act 1966. 5
