## **CUSTOMS ORDERS CONFIRMATION BILL**

### **EXPLANATORY NOTE**

THIS Bill confirms the Customs Tariff (Electronics) Amendment Order 1984, the Customs Tariff (Rubber) Amendment Order 1984, the Customs Tariff (Packing) Amendment Order 1984, and the Customs Tariff (Miscellaneous) Amendment Order 1984, as required by section 131 of the Customs Act 1966. These orders were made on or before 30 June 1984, and laid before Parliament during the present session.

Orders in Council made on or after 1 July 1984 and on or before 31 December 1984 are to be confirmed by an Act of Parliament before the close of the last day of the next ensuing session.

#### A BILL INTITULED

# An Act to validate and confirm certain Orders in Council made under the authority of the Customs Act 1966

WHEREAS by section 131 of the Customs Act 1966 (as amended by section 5 of the Customs Amendment Act 1973 and section 26 of the Customs Acts Amendment Act (No. 2) 1977) it is provided that every Order in Council made under section 124 or section 124A or section 125A of that Act on or after the 1st day of July in any calendar year and laid before 10 Parliament shall expire on the close of the last day of the next ensuing session of Parliament in the following calendar year except so far as it is expressly validated or confirmed by an Act of Parliament passed during that session; and every Order in Council made under section 124 or section 124A or section 125A of that Act on or before the 30th day of June in any calendar year and laid before Parliament shall expire on the close of the last day of that session except so far as it is expressly validated or confirmed by an Act of Parliament passed during that session: And whereas the Orders in Council specified in the Schedule to this Act have been made wholly or partly under the authority of the said section 124 on or before the 30th day of June 1984 and have been laid before Parliament during the present session, and it is desirable to validate and confirm those orders:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

- 1. Short Title—This Act may be cited as the Customs Orders Confirmation Act 1985.

- 2. Orders in Council confirmed—The Orders in Council specified in the Schedule to this Act are hereby declared to be valid and are hereby confirmed as required by section 131 of the Customs Act 1966.
- **3. Repeal**—The Customs Orders Confirmation Act 1983 is 10 hereby repealed.
