# DIVORCE AND MATRIMONIAL CAUSES BILL.

## EXPLANATORY MEMORANDUM. .

1. THE first Divorce Act was passed in England in the year 1857. It was amended from time to time, and remained in force until 1925, when a consolidation Act was passed (15 & 16 Geo. V., c. 49, ss. 176 to 200). The first Act dealing with divorce in New Zealand was the Divorce and Matrimonial Causes Act, 1867. It was copied for the most part from the English Act of 1857. In the present consolidation of the New Zealand law it seemed desirable to take advantage of the improvements made by the English Act, and that has been done. Of these may be noted the use of the word "divorce" instead of the words "dissolution of marriage."

2. The following are the more important changes proposed to be made in the law of New Zealand by this Bill :--

(a) The failure to comply with a decree for restitution of conjugal rights is made a ground for judicial separation. It is a ground in England, and is a ground for dissolution in New Zealand.

(b) The distinction between cases of adultery happening before and cases happening after the 1st June, 1899, has been abolished. Until the Divorce Act of 1898 was brought into operation on the 1st June, 1899, a wife could not obtain a divorce on the ground of adultery only, unless it was incestuous adultery or accompanied by bigamy; she had to prove in addition either cruelty or desertion for two years. The Act of 1898 altered the law on the subject, and gave a wife a right to obtain a divorce on the ground of adultery, if committed after the Act of 1898 came into force. When the Acts were consolidated in 1908 it was considered necessary to maintain the distinction between cases happening before the 1st June, 1899, and those happening after that date, but it seems to be unnecessary after the lapse of twenty-nine years to maintain the distinction. The only possible effect of the change would be to give a wife a right to a divorce in a case where her husband had committed adultery before the 1st June, 1899, and had not committed any matrimonial offence since which would give his wife a right to a divorce. The chance of there being such a case is remote indeed. If the distinction be abolished as proposed, then sections 22 and 23 of the Act of 1908 become unnecessary, and they have been dropped.

(c) The rule as to the retention of her domicile by a deserted wife, notwithstanding that her husband has changed his domicile, is extended by clause 12 so as to apply to the case of a wife who has been separated from her husband by agreement or otherwise.

(d) The subject of collusion has been cleared up, and the law declared to be that, except in the case of adultery, collusion is only a discretionary bar to relief.

(e) It has been made clear that connivance is a bar in the case of adultery only. This is necessary, for it is absurd to talk about connivance where relief is sought on other grounds, as, for, example the existence of an agreement for separation.

(f) Clause 33, dealing with alimony and maintenance, is taken from section 190 of the English Act of 1925. It gets rid of the confusion created by the apparently conflicting provisions of sections 41 and 42 of the Act of 1908, and gives the Supreme Court the additional powers possessed by the High Court in England.

(g) Section 29 of the Act of 1908 has been dropped. It appeared for the first time in the Act of 1898. It is difficult to know what it means, and would be better out of the way.

(h) The provisions contained in sections 68, 69, 70, and 71 are unnecessary, and have been dropped. They were taken for the most part from the English Act of 1857. The English Act of 1925 does not contain any such provisions.

(i) Section 74 of the Act is unnecessary, and has been dropped. The earlier provisions make clear the rights of a husband.

(j) Section 5 of the amending Act of 1912 (relating to the validity of certain marriages) has been omitted as spent.

# A BILL INTITULED

Title.

AN ACT to consolidate and amend the law relating to Divorce and Matrimonial Causes.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as  $\mathbf{5}$ follows :---

1. (1) This Act may be cited as the Divorce and Matrimonial Causes Act, 1928, and it shall come into force on the first day of January, nineteen hundred and twenty-nine.

(2) The enactments mentioned in the *First* Schedule hereto are 10 hereby repealed, and with respect to those enactments the following provisions shall apply:----

- (a) All Orders in Council, orders, decrees, regulations, rules, scales, registers, records, certificates, instruments, and generally all acts of authority which originated under any 15 of the said enactments and are subsisting or in force on the coming into operation of this Act shall enure for the purposes of this Act as fully and effectually as if they had originated under the corresponding provisions of this Act, and accordingly shall, where necessary, be deemed to 20 have so originated.
- (b) All matters and proceedings commenced under any such enactment and pending or in progress on the coming into operation of this Act may be continued, completed, and enforced under this Act.

(1) The Court shall in New Zealand have the same jurisdiction in relation to matrimonial causes and matters as was immediately before the commencement of the Matrimonial Causes Act, 1857 (Imperial), vested in or exerciseable by any Ecclesiastical Court or person in England in respect of divorce a mensa et thoro, nullity of marriage, jactitation of 40 marriage, or restitution of conjugal rights, and in respect of any other matrimonial cause or matter except marriage licenses; and the Court shall have such jurisdiction also in relation to divorce and other matrimonial causes and matters as is conferred by the provisions 45hereinafter contained.

(2) In all suits and proceedings other than proceedings for divorce the Court shall proceed and act and give relief on principles and rules which, in the opinion of the Court, as nearly as may be conform to the principles and rules upon which the Ecclesiastical Courts of England acted and gave relief, but subject to the provisions 50 of this Act and to the rules and orders made under this Act.

(3) Subject to the provisions of this Act and any rules made thereunder, all the powers and jurisdiction hereby given to the Court may be exercised by any Judge of the Court.

4. (1) Any three or more of the Judges of the Court, of whom Power to make and 5 the Chief Justice shall be one, may from time to time-

- (a) The Court shall satisfy itself so far as it reasonably can as to whether or not the petitioner has been accessory to or has connived at or condoned the adultery.
- (b) If on the evidence the Court is not satisfied that the alleged adultery has been committed, or finds that the petitioner has been accessory to or has connived at or condoned the adultery complained of, or that the petition is presented or prosecuted in collusion with either of the respondents, the **10** Court shall dismiss the petition.

(c) If the Court is satisfied on the evidence that the case for the petitioner has been proved, and does not find that the petitioner has been in any manner accessory to or has connived at or condoned the adultery, or that the petition is presented 15 or prosecuted in collusion with either of the respondents, the Court shall pronounce a decree of divorce :

Provided that this provision shall be subject to the discretion given to the Court by section sixteen of this Act.

(2) Where on the petition of a husband for divorce the alleged 20 adulterer is made a co-respondent, or where on the petition of a wife the person with whom her husband is alleged to have committed adultery is made a respondent, the Court, after the close of the evidence on the part of the petitioner, may direct such co-respondent or respondent to be dismissed from the suit if it thinks there is not 25 sufficient evidence against him or her.

18. In every case where the ground on which relief is sought is one of those specified in paragraphs (h), (i), and (j) of section *ten* of this Act, and the petitioner has proved his or her case, the Court shall have a discretion as to whether or not a decree shall be made; but if **30** upon the hearing of a petition praying for relief on the ground specified in paragraph (i) or paragraph (j) aforesaid the respondent opposes the making of a decree, and it is proved to the satisfaction of the Court that the separation was due to the wrongful act or conduct of the petitioner, the Court shall dismiss the petition. **35** 

19. In every other case where the petitioner has proved his or her case, then, subject to the special provisions hereinbefore contained, the Court shall pronounce a decree of divorce.

20. If in any suit or other proceeding instituted for divorce or judicial separation the respondent shall allege in his or her answer 40 any matter entitling either husband or wife to any relief under this Act, the Court may give to the respondent in such suit, on his or her application, the same relief as he or she would have been entitled to if he or she had filed a petition seeking such relief.

21. It shall be the duty of the Registrar, on the filing of any 45 petition for divorce, to send a copy thereof to the Solicitor-General.

22. (1) The Attorney-General or the Solicitor-General, if he thinks fit, may oppose the petitioner obtaining a decree for divorce or show cause why such a decree should not be made.

(2) When the ground of any petition for divorce is the unsoundness 50 of mind of the respondent it shall be the duty of the Solicitor-General

to take on behalf of the respondent such steps in the matter of the petition as he may consider necessary in the interests of the respondent.

(3) If from any such information or otherwise the Attorney-General or Solicitor-General suspects that any parties to the suit are or have been acting in collusion for the purpose of obtaining a divorce contrary

# PART III.

#### Remedies against Adulterers.

28. The action for criminal conversation is hereby abolished. 29. A husband may, on a petition for divorce or for judicial separation, claim damages from any person on the ground of his having committed adultery with the wife of the petitioner, but a petitioner shall not be entitled to claim damages in respect of adultery committed more than three years before the filing of his petition.

30. The claim made by such petition shall be heard and tried on the same principles, in the same manner, and subject to the same or the like rules as governed actions for criminal conversation when 10 heretofore tried and decided in the Supreme Court; and all the provisions herein contained with reference to the hearing and decision of petitions to the Court shall, so far as may be necessary, be deemed applicable to the hearing and decision of petitions presented under 15the last preceding section.

31. The damages to be recovered on any such petition shall in all cases be ascertained by the verdict of a jury, although the respondents or either of them may not appear; and after the verdict has been given such damages shall be paid or applied in such manner as the Court directs, and the Court may direct that the whole or any 20 part thereof shall be settled for the benefit of the children (if any) of the marriage, or as a provision for the maintenance of the wife:

Provided that if any such petition is dismissed no damages shall be recovered from the adulterer.

32. Where in any petition presented by a husband the alleged 25 adulterer has been made a co-respondent, or where in answer to his wife's petition a husband has alleged that his wife has committed adultery, and in any such case the adultery has been established, the Court may order the adulterer to pay the whole or any part of **3**0 the costs of the proceedings.

33. (1) The Court may, if it thinks fit, on any decree for divorce or nullity of marriage, order that the husband shall, to the satisfaction 35 of the Court, secure to the wife such gross sum of money or annual sum of money for any term, not exceeding her life, as, having regard to her fortune (if any), to the ability of her husband, and to the conduct of the parties, the Court may deem to be reasonable; and the Court may for that purpose order that it shall be referred to the Registrar 40 to settle and approve a proper deed or instrument, to be executed by all the necessary parties, and may, if it thinks fit, suspend the pronouncing of the decree until the deed or instrument has been duly executed.

(2) In any such case as aforesaid the Court may, if it thinks fit, by order, either in addition to or instead of an order under subsection one of this section, direct the husband to pay to the wife during the joint lives of the husband and wife such monthly or weekly sum for her 5 maintenance and support as the Court may think reasonable :

Provided that-

- (a) If the husband, after any such order has been made, becomes from any cause unable to make the payments, the Court may discharge or modify the order, or temporarily suspend the order as to the whole or any part of the money ordered to be paid, and subsequently revive it wholly or in part as the Court thinks fit; and

## PROCEDURE IN MATRIMONIAL CAUSES.

43. In questions of fact arising in proceedings under this Act it 25 shall be lawful for but, except as hereinbefore provided, not obligatory on the Court to direct the truth thereof to be determined by the verdict of a jury.

44. Where any such question is so ordered to be tried, such question shall be decided in the manner provided by any law now or 30 hereafter in force empowering the Court or a Judge thereof to direct an issue.

45. Every person seeking a divorce, or a decree of nullity of marriage, or a decree for judicial separation, or a decree in a suit of jactitation of marriage shall file, together with the petition or other 35 application for relief, an affidavit verifying the same so far as the deponent is able to do so, and stating that there is not any collusion between the deponent and the other party to the marriage, and also, in every case where adultery is alleged, that there is not any connivance between the deponent and the other party to the marriage. 40 46. In addition to the above, all disbursements for fees of Court, fees of officers, expenses of service, witnesses' expenses actually paid, and all other necessary payments shall be allowed.
