A BILL INTITULED

AN ACT for better securing the Freedom and Inde-Title. pendence of Parliament.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows-

1. The Short Title of this Act shall be "The Disqualification short Title. Act 1868.'

 $\mathbf{5}$ 2. This Act shall commence and come into operation from and Commencement of after the termination of this present Parliament by dissolution or Act. otherwise.

3. "The Disqualification Act 1858" so far as the same relates "The Disqualification to elections of Members to serve in the House of Representatives and Act 1858" repealed so far as it relates to 10 to persons elected to serve as Members of the said House shall on the House of coming into operation of this Act be repealed.

4. A Member of the Legislative Council shall not be capable of MemberofLegislative being elected or of sitting or voting as a Member of the House of of being elected to Representatives.

- 5. No person except as is hereinafter specially provided accepting Officersofthe Governmenters 15 or holding any office commission or employment permanent or tempo-rary under or from or by or at the appointment or nomination of the Legislative Council or Crown or the Governor of New Zealand by virtue of his office as of being elected to However or at or by the nomination or appointment of any officer of However Governor or at or by the nomination or appointment of any officer of Representatives.
- 20 the Government of New Zealand by virtue of his office or under or from or by or at the appointment or nomination of the Superintendent of any Province by virtue of his office or at or by the nomination or appointment of any officer of any Provincial Government by virtue of his office to which any salary fees wages allowance emolument or profit
- 25 of any kind is attached shall be capable of being summoned to or of holding a seat in the Legislative Council or of being elected to serve as a member of the House of Representatives or of sitting or voting as a member either of the said Council or the said House during the time he holds such office occupation or employment.

Nothing in the last section shall render incapable of being Exception as to summoned to the said Council or of being elected to serve as a member of the Crown &c. of the said House or disqualify to sit or vote in the said Council or House any person being a member of the Executive Council of the Colony or any person being a member of the said Executive Council

any office other than those of Colonial Secretary Colonial Treasurer Commissioner of Customs or Postmaster-General to which he has been or may hereafter be appointed by the Governor Provided however that nothing in the last section contained shall render incapable of being summoned to the Legislative Council or disqualify 5 to sit or vote therein the person for the time being holding the office of Secretary for Crown Lands whether he at the same time holds any other offices or places of profit such as are specified in the said last section or not.

7. Nothing in the said fifth section contained shall render 10 incapable of being summoned to the Legislative Council or of being elected to serve as a member of the said House of Representatives or shall disqualify to sit or vote in the said Council or House any person holding the office of Superintendent of a Province in New Zealand or any officer in Her Majesty's army or navy or any officer or person 15 temporarily placed on pay for defence purposes or any officer in the militia or militiaman in the New Zealand Militia (except officers on the staff of the said militia receiving annual or permanent salaries) or any officer or member of any volunteer corps unless in any such case such person be otherwise disqualified by reason of holding some office 20 or employment other than those mentioned in this section.

8. No person who shall directly or indirectly by himself or by any person in trust for him or for his use or benefit hold enjoy undertake or execute or be directly or indirectly in any way concerned or interested in any contract or agreement with Her Majesty or with any 25 officer or department of the Government of New Zealand with respect to the public service of New Zealand or under which any public money of the Colony is to be paid for any service work matter or thing shall be capable of being summoned to or of holding a seat in the Legislative Council or of being elected to serve as a member of 30 the House of Representatives nor shall any such person sit or vote in the said Council or House during the time he shall hold enjoy execute or be interested in any such contract or agreement Nothing hereinbefore in this section contained shall extend or apply to any bargain or contract entered into by any company partnership or association 35 consisting of more than twenty persons where such bargain or contract shall be entered into for the general benefit of such company partnership or association or to any lease license for occupation sale or purchase of any land or to any agreement for any such lease sale or purchase or for the occupation of such land or for any easement 40 therein or for the loan of money or to any security for the payment of money only.

9. If any person hereby disqualified or declared incapable of being elected a member of the House of Representatives is nevertheless elected and returned as a member of the said House his election 45 and return shall be null and void.

10. If any member of the Legislative Council or House of Representatives shall by accepting any office or becoming a party to any contract or agreement become disqualified under the foregoing provisions from continuing to sit or vote in the said Council or 50 House the seat of such member shall thereby be vacated and if a member of the House of Representatives his election shall thereby become void.

11. If any person disqualified or declared incapable of sitting or voting in the Legislative Council or House of Representatives by 55 any of the provisions hereinbefore contained shall presume to sit or vote therein he shall thereby forfeit the sum of one hundred pounds for each and every day on which he so sits or votes and such sum may be recovered from him by any person who may sue for the same in 60 any Court of competent jurisdiction in New Zealand.
