A BILL INTITLED

An Act to amend the Decimal Currency Act 1964, and to amend certain other enactments of the General Assembly in relation to the introduction of the system of decimal currency

5 BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

No. 118—2

1. Short Title—This Act may be cited as the Decimal Currency Amendment Act 1965.

PART I

TRANSITIONAL PROVISIONS AND MISCELLANEOUS AMENDMENTS

5

2. This Part to be read with Decimal Currency Act 1964—

(1) This Part of this Act shall be read together with and deemed part of the Decimal Currency Act 1964* (in this Part referred to as the principal Act).

(2) Except as otherwise provided in this Part, this Part 10 shall come into force on the commencement of Part II of the principal Act.

3. Interpretation—In this Part of this Act, unless the context otherwise requires,—

“Bill of exchange”, or “bill”, includes any instrument 15 to which section 5 of the Cheques Act 1960 applies:

“Transitional period” means the period commencing on the date of the commencement of Part II of the principal Act and ending with a date to be appointed by the Governor-General by Proclamation. 20

4. Certain coins in existing currency deemed to be decimal coins—Section 10 of the principal Act is hereby amended by adding the following subsection:

“(6) The following coins in the existing currency, namely, the florin, the shilling, and the sixpence, shall be deemed 25 for all purposes to be decimal coins duly made and issued under this Act of the denominations of twenty cents, ten cents, and five cents respectively.”

5. Use of certain other coins in existing currency during transitional period—During the transitional period, and 30 unless in respect of any transaction the parties otherwise agree,—

(a) Coins in the existing currency of the denominations specified in the first column of the First Schedule to this Act shall, on the basis of the equivalent 35 decimal values specified in the second column of that Schedule opposite those denominations, be exchangeable for decimal coins in lots only of five cents’ worth or a multiple thereof; and

(b) A tender of payment in such coins shall accordingly, if made in the same lots, be a legal tender for the payment of an amount not exceeding twenty cents.

6. Payment in decimal currency of bill of exchange or promissory note made in existing currency—(1) Where before the date of the commencement of this Act, a bill of exchange or promissory note is issued or made according to the existing currency, and the bill or note is not paid before that date, any sum specified in it shall be converted into decimal currency in accordance with subsection (2) of this section.

(2) The said sum shall be converted on the basis of the equivalents specified in subsection (4) of section 5 of the principal Act, except that pence amounting to less than one shilling shall be converted into cents on the basis that an amount of pence specified in the first column of the Second Schedule to this Act corresponds to the amount of cents specified in the second column of that Schedule opposite that amount of pence.

(3) Where at any time during the transitional period it is necessary to alter any sum specified in any such bill or note for the purpose of facilitating its negotiation, collection, or payment, and the alteration is made in accordance with this section, the alteration shall not render the bill or note void as against any party.

7. Payment of sum in existing currency by bill of exchange or promissory note made in decimal currency—Where a bill of exchange or promissory note issued or made according to decimal currency is taken in respect of any sum payable according to the existing currency, the conversion of that sum into decimal currency shall be made in accordance with subsection (2) of section 6 of this Act, and that subsection shall apply accordingly.

8. Acknowledgment of payment during transitional period—Where in respect of any payment made during the transitional period it is necessary, by reason of the use of a machine or instrument that operates according to the existing currency, to provide an acknowledgment expressed in the existing currency, the reference in the acknowledgment to the sum paid shall be construed as a reference to the corresponding sum in decimal currency, calculated in accordance with subsection (2) of section 6 of this Act.

9. Closing of banks—(1) Section 19 of the principal Act is hereby amended by adding the following subsection:

“(5) Any day appointed by the Minister under subsection (1) of this section shall be deemed for the purposes of the Bills of Exchange Act 1908 to be a non-business day.”

(2) This section shall come into force on the passing of this Act.

10. Jurisdiction of Ombudsman in respect of Decimal Currency Board—(1) The Parliamentary Commissioner (Ombudsman) Act 1962 is hereby amended by inserting in Part II of the Schedule, after the reference to the Board of Maori Affairs, the words “The Decimal Currency Board”.

(2) This section shall come into force on the passing of this Act.

11. Scale of rates of estate duty—(1) The Estate and Gift Duties Act 1955 is hereby amended by repealing the First Schedule (as substituted by section 2 (1) of the Estate and Gift Duties Amendment Act 1964), and substituting the new First Schedule set out in the Third Schedule to this Act.

(2) Section 2 of the Estate and Gift Duties Amendment Act 1964 is hereby consequentially repealed.

(3) This section shall be deemed to have come into force on the twenty-fifth day of June, nineteen hundred and sixty-four (being the date of the commencement of section 2 of the Estate and Gift Duties Amendment Act 1964) and shall apply and be deemed to have applied to the estates of all persons dying on or after that date.

12. Scale of rates of gift duty—(1) The Estate and Gift Duties Act 1955 is hereby further amended by repealing the Second Schedule (as substituted by section 4 (1) of the Estate and Gift Duties Amendment Act 1961), and substituting the new Second Schedule set out in the Fourth Schedule to this Act.

(2) Subsections (1) and (3) of section 4 of the Estate and Gift Duties Amendment Act 1961 are hereby consequentially repealed.

(3) This section shall apply and be deemed to have applied with respect to all gifts made on or after the twentieth day of July, nineteen hundred and sixty-one (being the date of the commencement of the Estate and Gift Duties Amendment Act 1961):

Provided that, in ascertaining the rate of gift duty in respect of a gift made before that date, the value of any gift or gifts made on or after that date shall not be taken into account unless the gift made before that date together with the 5 value of all aggregated gifts (including the gift or gifts made on or after that date) exceeds one thousand pounds.

13. Final balance of estate, and value of successions and gifts, for duty purposes—The Estate and Gift Duties Act 1955 is hereby further amended—

- 10 (a) By omitting from subsection (3) of section 6 the words “complete pounds”, and substituting the words “complete dollars”;
- (b) By omitting from subsection (3) of section 23 the words “complete pounds”, and substituting the words “complete dollars”;
- 15 (c) By omitting from subsection (2) of section 51 the words “complete pounds”, and substituting the words “complete dollars”.

14. Amendments to other enactments—(1) The enactments specified in the Fifth Schedule to this Act are hereby amended in the manner indicated in that Schedule.

(2) The amendments made by this section to subsection (1) of section 22 of the Customs Acts Amendment Act 1934 (which relates to the rates of excise duty on tobacco manufactured in New Zealand) shall apply with respect to tobacco entered for home consumption after the commencement of Part II of the Decimal Currency Act 1964.

PART II

AMENDMENTS TO LAND AND INCOME TAX ACT 1954

30 **15. This Part to be read with Land and Income Tax Act 1954**—This Part of this Act shall be read together with and deemed part of the Land and Income Tax Act 1954* (in this Part referred to as the principal Act).

16. Commencement and application—(1) Sections 17 to 22 of this Act and the Sixth Schedule to this Act shall come into force on the first day of April, nineteen hundred and sixty-seven.

(2) Section 23 of this Act and the Seventh Schedule to this Act shall come into force on the date of the commencement of Part II of the Decimal Currency Act 1964.

(3) Sections 17 to 20 of this Act shall apply with respect to the tax for the year of assessment commencing on the first day of April, nineteen hundred and sixty-seven, and for every subsequent year. 5

17. Land tax payable by certain charities, etc.—Section 74 of the principal Act is hereby amended by omitting from paragraph (b) of subsection (1) the words “one half-penny 10 for every pound”, and substituting the words “sixpence for every twelve pounds”.

18. Rate of income tax on dividends—Section 78A of the principal Act (as inserted by section 5 of the Land and Income Tax Amendment Act (No. 2) 1958) is hereby amended by 15 omitting from subsection (1) the words “seven shillings on each pound”, and substituting the words “three shillings and sixpence on each ten shillings”.

19. Rate of income tax on interest from National Development Loans—(1) Section 79 of the principal Act (as amended by section 3 (1) of the Land and Income Tax Amendment Act 1956) is hereby further amended by omitting from subsection (2) the words “nine shillings and fourpence on each pound of that interest where the rate of the interest is three and three-quarters per cent per annum or an amount calculated at the rate of ten shillings on each pound of that interest where the rate of the interest is four per cent per annum”, and substituting the words “four shillings and eightpence on each ten shillings of that interest where the rate of the interest is three and three-quarters per cent per annum or an amount 20 25 calculated at the rate of five shillings on each ten shillings of that interest where the rate of the interest is four per cent per annum”. 30

(2) Section 3 of the Land and Income Tax Amendment Act 1956 is hereby consequentially amended by repealing 35 subsection (1).

20. Companies engaged in mining for certain minerals— Section 152 of the principal Act (as substituted by section 30 of the Land and Income Tax Amendment Act 1965) is hereby amended by omitting from subsection (3) the words “at the 5 rate ascertained by dividing the total tax paid or payable in respect of those dividends by the number of pounds”, and substituting the words “by multiplying the number of half-pounds included in that amount by the product ascertained by dividing the total tax paid or payable in respect of those 10 dividends by the number of half-pounds”.

21. Remission of excess retention tax— Section 172H of the principal Act (as substituted by section 27 of the Land and Income Tax Amendment Act 1959) is hereby amended by omitting from subsection (1) the words “seven shillings on 15 each pound”, and substituting the words “three shillings and sixpence on each ten shillings”.

22. Basic rates of income tax, excess retention tax, and bonus issue tax—(1) The principal Act is hereby further amended by repealing the First Schedule (as substituted by 20 section 4 (1) of the Land and Income Tax Amendment Act 1962), and substituting the new First Schedule set out in the Sixth Schedule to this Act.

(2) The following enactments are hereby consequentially repealed:
25 (a) Section 4 of the Land and Income Tax Amendment Act 1962 and the First Schedule to that Act;
(b) Section 4 of the Land and Income Tax Amendment Act 1964;
(c) Subsection (1) of section 8 and section 32 of the Land 30 and Income Tax Amendment Act 1965.

23. Basic tax deductions—(1) The First Schedule to the Income Tax Assessment Act 1957 (as substituted by section 22 (1) of the Land and Income Tax Amendment Act (No. 2) 1959 and amended by section 3 (1) (a) of the Land and 35 Income Tax Amendment Act 1963) is hereby further amended—

(a) By omitting from subclause (2) of clause 5 the words “4s. 3d. per £1”, and substituting the words “21c per \$1”:

- (b) By omitting from clause 6 the expression “£4” wherever it occurs, and substituting in each case the expression “\$8”;
- (c) By omitting from paragraph (a) of subclause (3) of clause 6 the expression “£20”, and substituting the expression “\$40”;
- (d) By omitting from subclause (3) of clause 7 the words “1s. 6d. per £1”, and substituting the words “1c in every 13½c”;
- (e) By omitting from clause 8 the words “4s. 3d. per £1”, 10 and substituting the words “21c per \$1”.

(2) The said First Schedule to the Income Tax Assessment Act 1957 is hereby further amended by repealing Appendix A and Appendix B (as substituted by section 3 (1) (b) of the Land and Income Tax Amendment Act 1963), and substituting the new Appendix A and Appendix B set out in the Seventh Schedule to this Act. 15

(3) The Land and Income Tax Amendment Act 1963 is hereby consequentially repealed.

1. Interpretation—For the purposes of clauses 2 to 5 of this Part of this Schedule—

“Taxable income” means income on which ordinary income tax is payable.

2. Debentures issued free of income tax by companies—On income derived from debentures issued by a company on terms providing for the payment of income tax by the company, as provided in section 109 of this Act, the basic rate of ordinary income tax for every 10s. of the taxable income shall be 4s. 3d.

3. Maori authorities—On all undistributed income assessable to a Maori authority under section 160 of this Act the basic rate of ordinary income tax for every 10s. of the taxable income shall be 1s. 3d.

4. Companies and public authorities—(1) For the purposes of this clause, the effective rate of tax for any income shall—

(a) In the case of—

(i) A company that is deemed to be resident in New Zealand within the meaning of Part VI of this Act; and

(ii) A public authority,—

be ascertained by calculating tax on that income in accordance with the rates of tax specified in Part B of this Schedule and dividing the tax so calculated by the number of half-pounds included in that income:

(b) In the case of a company that is not deemed to be resident in New Zealand within the meaning of Part VI of this Act, be ascertained by calculating tax on that income in accordance with the rates of tax specified in Part C of this Schedule and dividing the tax so calculated by the number of half-pounds included in that income.

(2) On all income not included within clause 2 or clause 3 of this Part of this Schedule the basic rates of ordinary income tax shall, in the case of companies and public authorities, be as provided in this clause.

(3) Where the total income derived by the company or the public authority during the income year did not include any non-assessable income, the basic rate for every 10s. of the taxable income shall be a rate equal to the effective rate of tax for the taxable income.

(4) Where the total income derived by the company or the public authority during the income year included non-assessable income, the basic rate for every 10s. of the taxable income shall be a rate equal to the effective rate of tax for an income equal in amount to the total of the taxable income and of that non-assessable income.

SIXTH SCHEDULE—continued

5. Other taxpayers—(1) For the purposes of this clause, the effective rate of tax for any income shall be ascertained by calculating tax on that income in accordance with the rates of tax specified in Part D of this Schedule and dividing the tax so calculated by the number of half-pounds included in that income.

(2) On all income not included within clause 2 or clause 3 of this Part of this Schedule the basic rates of ordinary income tax shall, in the case of all taxpayers other than companies and public authorities, be as provided in this clause.

(3) Where the total income derived by the taxpayer during the income year—

(a) Did not exceed £1,300; or

(b) Exceeded £1,300 and did not include any non-assessable income—the basic rate for every 10s. of the taxable income shall be a rate equal to the effective rate of tax for the taxable income.

(4) Where the total income derived by the taxpayer during the income year exceeded £1,300 and included non-assessable income, the basic rate for every 10s. of the taxable income shall be a rate equal to the effective rate of tax for an income equal in amount to the total of the taxable income and of that non-assessable income.

Social Security Income Tax

6. Interpretation—For the purposes of clause 7 of this Part of this Schedule—

“Taxable income” means income on which social security income tax is payable.

7. All taxpayers—On all income the basic rate of social security income tax shall be 1½d. for every sum of 16d. or part thereof of the taxable income.

Excess Retention Tax

8. Companies—On the amount of an insufficient distribution assessable to a company under Part VIA of this Act, the basic rate of excess retention tax for every 10s. of that amount shall be 3s. 6d.

Bonus Issue Tax

9. Companies—On the amount of a bonus issue assessable to a company under Part VI_B of this Act, the basic rate of bonus issue tax for every 10s. of that amount shall be 1s. 9d.
