

## DAIRY INDUSTRY AMENDMENT BILL

---

### EXPLANATORY NOTE

*Clause 2* provides that a separate charge of a limited amount may be made by dairy companies in respect of each assignment or order on milk cheques made by suppliers instead of a limited charge on all assignments or orders, as is the case at present.

*Clause 3* extends the powers conferred by the principal Act to make regulations. It is proposed that regulations may be made—

- (a) Regulating the processing of milk and requiring persons engaged in the processing of milk to be the holders of certificates;
- (b) Providing for the marking of utensils used for dairy produce in cases where the use of the utensils has been forbidden by an Inspector; and
- (c) Regulating the sampling, testing, and grading of milk or cream received at milk treatment stations.

### A BILL INTITULED

AN ACT to amend the Dairy Industry Act 1952. Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. This Act may be cited as the Dairy Industry Amendment Act 1955, and shall be read together with and deemed part of the Dairy Industry Act 1952 (hereinafter referred to as the principal Act). Short Title.

10 2. Subsection *two* of section twenty-nine of the principal Act is hereby amended as follows: Charges by dairy companies in respect of assignments or orders on milk cheques.

(a) By omitting the words "all assignments or orders", and substituting the words "each assignment or order":

15 (b) By omitting the words "such assignments or orders", and substituting the words "such assignment or order".

20 3. (1) Subsection one of section thirty-two of the principal Act is hereby amended by inserting, after paragraph (d), the following paragraph: Extension of power to make regulations.

“(dd) Regulating the processing of milk and requiring persons engaged in the processing of milk to be the holders of certificates of competency under the regulations:”

(2) Subsection one of section thirty-two of the principal Act is hereby further amended by inserting, after paragraph (f), the following paragraph: 5

“(ff) For the marking and method of marking for identification purposes of utensils used in or about dairies or in connection with the manufacture, deposit, or carriage of dairy produce in cases where the use of the utensils for dairy produce has been forbidden under section seven of this Act:” 10

(3) Subsection one of section thirty-two of the principal Act is hereby further amended by inserting, after paragraph (r), the following paragraph: 15

“(rr) For regulating the sampling, testing, and grading of milk or cream delivered to or received at milk treatment stations:” 20
