A BILL INTITULED

AN ACT to Amend the Dairy Products Marketing Title. Commission Act, 1947.

BE IT ENACTED by the General Assembly of New 5 Zealand in Parliament assembled, and by the authority of the same, as follows:----

1. This Act may be cited as the Dairy Products Short Title. Marketing Commission Amendment Act, 1948, and shall

be read together with and deemed part of the Dairy 1947, No. 2 10 Products Marketing Commission Act, 1947 (hereinafter

referred to as the prinicpal Act).

2. Section two of the principal Act is hereby amended Interpretation. by inserting, after the definition of the term "Dairy Board ", the following definition:--

"' Dairy-produce ' includes-"(a) Milk and cream; and 15

"(b) Butter, cheese, and all other products of milk or cream, whether derived therefrom by manufacturing processes or otherwise:".

3. Section eleven of the principal Act is hereby **5** amended by inserting in subsection one, after the word "therefor ", the words "to control the export of dairy-produce other than butter or cheese ".

4. (1) The heading to Part II of the principal Act is hereby amended by omitting the words "Butter and 10 Cheese", and substituting the word "Dairy-produce".

(2) Section thirteen of the principal Act is hereby amended as follows:—

- (a) By adding to subsection one the words "and with respect to all dairy-produce, other than 15 butter and cheese, that is intended for export":
- (b) By omitting from subsection two the words "butter and cheese", and substituting the word "dairy-produce".

5. (1) Section fourteen of the principal Act is hereby amended by repealing paragraph (a), and substituting the following paragraphs:—

- "(a) For the acquisition and marketing by the Commission of any dairy-produce, other than 25 butter and cheese, to which this Part of this Act applies, and for prohibiting, restricting, and controlling the export of any such dairyproduce by other persons:
- "(*aa*) For the handling, pooling, transport, and 30 storage of any dairy-produce to which this Part of this Act applies:".

(2) The said section fourteen is hereby further amended by omitting from paragraphs (b), (c), (d), and (e) the words " butter or cheese ", and substituting in 35 each case the word " dairy-produce ".

6. The principal Act is hereby amended by repealing section seventeen, and substituting the following section:—

"17. For the purpose of conducting any inquiry 40 necessary or desirable for the carrying-out of any of its functions under this Act and for the purpose of obtaining
