A BILL INTITULED

An Act to amend "The Dog Registration Act, 1880." Title. WHEREAS it is expedient to amend the law relating to the regis- Preamble. tration of dogs:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same. as follows:-

1. The Short Title of this Act is "The Dog Registration Act Short Title. Amendment Act, 1882."

It shall be deemed to be incorporated with "The Dog Regis-10

tration Act, 1880" (hereinafter referred to as "the said Act").

2. Notwithstanding anything contained in the said Act, the local Registration fee to authority having jurisdiction within any district may, by notification be fixed by local authority. published in a newspaper having general circulation within the district. 15 appoint the fee to be paid for the registration of any dog within such district to be such sum, not exceeding ten shillings and not less than five two shillings and sixpence, as the said authority shall think fit.

Provided that when dogs are kept for the sole purpose of the management of live stock, or for the destruction of rabbits, it shall be 20 lawful for any County Council or Highway Board such local authority to reduce the fee for the registration of any such dog to such sum, not being less than one shilling, as such Council or Board shall determine.

3. In any case wherein a County Council or Highway Board any Declaration. local authority shall, in pursuance of the discretionary power by the 25 proviso to section two of this Act conferred, have determined to permit the registration of dogs kept for either of the purposes therein mentioned at any reduced fee, every person claiming to register any dog at No. 90—3.

Penalty for false declaration.

such reduced fee shall be required to sign a declaration in the form of the *First* Schedule hereto; and if any such declaration be false or untrue, the person wilfully making such false declaration shall be liable to a penalty not exceeding *twenty* pounds, or to imprisonment for any period not exceeding one month.

Penalty for nonfiegistration by date exed not to apply in rertain cases. 4. Where any person, without having been summoned to enforce payment of the registration fee in respect of any dog in his possession or following, shall have paid such registration fee after the time limited for such registration, he shall be exempted from the penalty imposed by the said Act for not effecting such registration within the 10 proper time, and shall not be liable to be summoned for the payment of such penalty. But this section shall not operate as a bar to the conviction or fining of any person against whom an information shall have been laid prior to the payment of such registration fee.

Provise to section 13 of "Dog Registration Act, 1880."

Registration label may be fixed to 5. Provided that any dog, instead of being destroyed as aforesaid, may be seized and kept by the police or by any one duly authorized by the local authority, and if not claimed and the expenses of the dog's keep paid by the owner within seven days from the time of such seizure, may be sold and disposed of to any person, and such person 20 shall thereupon become the lawful owner of the same; and the proceeds of any such sale as aforesaid shall be paid into the funds of the local authority.

This proviso shall be read as a proviso to section thirteen of "The

Dog Registration Act, 1880."

6. Whenever a dog is duly registered under the said Act, it shall be lawful for the owner to affix the registration-label obtained from the registration office on any dog-collar other than one obtained from the said office.
