A BILL INTITULED

An Act to enable the Corporation of the Mayor, Councillors, and Title. Citizens of the City of Dunedin to take, divert, and impound Water from the Taieri River and certain of its Tributaries, for the Use of the Inhabitants of the said City. 5

WHEREAS it is expedient to enable the Corporation of the Mayor, Preamble. Councillors, and Citizens of the City of Dunedin (hereinafter referred to as "the said Corporation"), to obtain from time to time an additional supply of water for the use of the inhabitants of the said city:

BE IT THEREFORE ENACTED by the General Assembly of New 10 Zealand in Parliament assembled, and by the authority of the same, as follows:-

1. The Short Title of this Act is "The Dunedin Water-supply Short Title. Extension Act, 1882."

2. It shall be lawful for the said Corporation, at any time or corporation may times hereafter, to take, divert, and impound water from the Taieri divert water from Taieri River. River and its tributaries, at such points or places therein respectively as are severally and respectively described in the Schedule hereto, for the use and benefit of the inhabitants of the said City of Dunedin.

20 3. The said Corporation shall not be liable in any manner whatsoever to indemnify or make any kind of compensation to any ownersation. or occupier of land abutting upon or adjoining the said Taieri River or any of its tributaries, for or by reason of any alleged deprivation of or interference with the riparian rights or interests of such owner or 25 occupier in relation to the said Taieri River or any of its tributaries. by reason or in consequence of any such taking, diversion, and impounding of water by or on behalf of the said Corporation as aforesaid.

SCHEDULE.

1. Big Mount Allan Creek: At any point situated within Blocks one or two. Silver Peak Survey District.

2. Little Mount Allan Creek: At any point situated within Block four, Silver

Peak Survey District.

3. Christmas Creek: At any point situated within Blocks four or six, Silver Peak Survey District.

4. Three o'Clock Creek: At any point situated within two miles from its junction

with the Taieri River.

5. Deep Stream: At any point situated within Block three, Mount Hyde Survey District; or within Blocks ten and eleven, Nenthorn Survey District.

6. Ross Creek: At any point situated within one mile from its junction with the Taieri River.

6. Nenthorn Stream: At any point situated within two miles from its junction with the Taieri River.

8. Taieri River: At any point situated within Blocks one, five, or six, Nenthorn Survey District; or within Blocks three or thirteen, Sutton Survey District.

9. Sutton Stream: At any point situated within Block three, Sutton Survey District.
