Title.

A BILL INTITULED

AN ACT to consolidate and amend certain enactments of the General Assembly relating to electricians and electrical wiring work.

BE IT ENACTED by the General Assembly of New 5 Zealand in Parliament assembled, and by the authority of the same, as follows:---

1. This Act may be cited as the Electricians Act 1952, and shall come into force on the first day of April. nineteen hundred and fifty-three.

"Apprentice" means a person who is serving a term of apprenticeship and who has,-

(a) In the case of an apprentice under the 15Master and Apprentice Act 1908, within three months after the termination of any probationary period, entered into a written contract, duly signed and witnessed, to serve an employer and to learn and be taught the 20 electrical wiring trade or any branch thereof approved by the Board and to abide by any conditions which may be set down in the contract: or

(b) In the case of an apprentice under the 25Apprentices Act 1948, entered into a contract in writing, duly consented to by the appropriate local Apprenticeship Committee or the Court of Arbitration and registered by the District Commissioner of Apprenticeship 30 under that Act, to serve an employer and to learn and be taught the electrical wiring trade or any branch thereof approved by the Board and to abide by any conditions which may be set down in the contract: 35

(3)The General Manager of the State Hydro-electric Department may, for purposes of defence or public security, direct that the inspection, testing, and approval of any electrical wiring work on or in any land or building owned or occupied by the Crown shall be made 20 and given by a person authorized by him in that behalf; and, while any such direction remains in force in respect of any such land or building, no other person shall inspect, test, or approve any electrical wiring work on or in that land or building. 25

(4) Notwithstanding anything to the contrary in this Act, the inspection, testing, and approval of any electrical wiring work for which a supply of electrical energy will be obtained from a Department of State may be made and given by a person for the time being authorized in 30 that behalf by the General Manager of the State Hydroelectric Department; and, where for the time being any person is authorized under this subsection to make any such inspection or testing or give any such approval for the purposes of this Act, no other person shall do so. 35

4. (1) There shall be a Board (to be known as the Electricians: Registration Board) which shall be the same Board as that existing under the name of the Electrical Wiremen's Registration Board at the com- 40 mencement of this Act.

(2) The Board shall consist of ----

- (a) The General Manager of the State Hydroelectric Department, who shall be the Chairman:

- (d) One electrical engineer who shall be appointed on the recommendation of a body recognized by the Minister as representing electrical traders and electrical contractors in New Zealand:
- (e) One registered electrician who shall be appointed on the recommendation of a body recognized by the Minister as representing registered electricians in New Zealand:
- (f) One registered electrician who shall be appointed on the recommendation of a combined group of unions recognized by the Minister as representing registered electricians who are employed in the electrical industry in New Zealand.

(3) Every member of the Board, other than the General Manager of the State Hydro-electric Department, shall be appointed by the Minister for a term of

- 35 three years, but may from time to time be reappointed. or may be at any time removed from office by the Minister for disability, insolvency, neglect of duty, or misconduct, or may at any time resign his office by writing addressed to the Minister.
- (4) If any member of the Board dies, resigns, or is 40 removed from office, the vacancy so created shall, as soon as practicable, be filled in the manner in which the appointment to the vacant office was originally made. Every person so appointed shall be appointed for the
- 45 residue of the term for which his predecessor was appointed.

(5) Unless he sooner vacates his office as hereinbefore provided, every appointed member of the Board shall continue in office until his successor comes into office, notwithstanding that the term for which he was appointed may have expired.

(6) The powers of the Board shall not be affected by any vacancy in the membership thereof.

5. (1) Meetings of the Board shall be held at such times and places as the Board or the Chairman from time to time determines, but any two members of the 10 Board may at any time, by notice in writing, request the Chairman to call a special meeting of the Board, and thereupon the Chairman shall call a special meeting to be held not later than one month after he received the notice. 15

(2) At every meeting of the Board three members shall form a quorum.

(3) Every question before the Board shall be determined by a majority of the votes of the members present at a meeting of the Board.

(4) At every meeting of the Board the Chairman of that meeting shall have a deliberative vote, and, in the case of an equality of votes, shall also have a casting vote.

(5) In the event of the absence of the General 25 Manager of the State Hydro-electric Department from any meeting of the Board, some other person to be appointed by him for the purpose, being an electrical engineer of the State Hydro-electric Department, may attend, and shall for the purposes of that meeting be 30 deemed to be a member of the Board, but he shall not be deemed to be Chairman of that meeting by virtue of the fact that he attends as deputy of the General Manager of the State Hydro-electric Department.

(6) In the absence of the Chairman from any meeting 35 of the Board the members present thereat shall choose one of their number to be chairman of that meeting.

6. There shall be paid to the members of the Board remuneration by way of fees, salary, or allowances, and travelling allowances and expenses in accordance with 40 the Fees and Travelling Allowances Act 1951, and the provisions of that Act shall apply accordingly, and the Board shall be a statutory Board for the purposes of that Act.

- (d) Generally, within the scope of its authority, to do whatever may in its opinion be necessary for the effective administration of this Act.

Registration, Licences, and Authorities

8. (1) There shall from time to time be appointed Registrar of 30 under the provisions of the Public Service Act 1912 a Electricians. The office may be held 1925, No. 23, Registrar of Electricians. concurrently with any other office.

(2) The person holding office at the commencement of this Act as Registrar of Electrical Wiremen shall be 35 deemed to have been duly appointed as Registrar of Electricians.

10. The Board shall not direct the registration or licensing of any applicant unless, in the opinion of the Board, he is of good character and reputation.

11. (1) Except as provided in section ten of this Act, every person shall, on payment of the prescribed 5 fee, be entitled to be registered under this Act as an electrician if he satisfies the Board—

(a) That he is not less than twenty years of age; and

- (b) That he has had experience satisfactory to the 10 Board for not less than ten thousand hours, or for such other period as may from time to time be prescribed by regulations made under this Act or as the Board may in any case approve, as an apprentice in the work of an 15 electrician; and
- (c) That he is the holder of a certificate that he has passed the Electricians' Examination conducted in accordance with regulations made or continuing in force under this Act or an 20 examination approved by the Board as sufficient for the purpose.

(2) Except as provided in section ten of this Act, every person shall, on payment of the prescribed fee, be entitled to be registered under this Act as an 25 electrical serviceman if he satisfies the Board—

- (a) That he is not less than twenty years of age; and
- (b) That he has had experience satisfactory to the Board for not less than eight thousand hours, 30 or for such other period as may from time to time be prescribed by regulations made under this Act or as the Board may in any case approve, as an apprentice in the class of work in respect of which he has applied for registration or, where more than one class is applied for, not less than four thousand hours or such other period as may from time to time be prescribed or approved as aforesaid in each such class with a minimum of eight thousand 40 hours or such other period as may from time to time be prescribed or approved as aforesaid; and

(c) That he is the holder of a certificate that he has passed the prescribed examination or examinations conducted in accordance with regulations made or continuing in force under this Act or an examination approved by the Board as sufficient for the purpose.

(3) Except as provided in section ten of this Act, every person shall, on payment of the prescribed fee, be entitled to limited registration under this Act if he 10 satisfies the Board-

- (a) That he is not less than nineteen years of age; and
- (b) That he has had experience to the satisfaction of the Board and in accordance with this Act
 - for not less than three years in the class of work in respect of which he has applied for registration; and
- (c) That he is the holder of a certificate that he has passed the prescribed examination or examina
 - tions conducted in accordance with regulations made or continuing in force under this Act or an examination approved by the Board as sufficient for the purpose.
- (4) Where the Board considers it desirable to do so 25 in order to provide operatives for any specialized branch of the electrical industry to service equipment which the Board considers essential to the public welfare, the Board may grant limited registration to any person who would not qualify for registration under the foregoing
- 30 provisions of this section if the person satisfies the Board-
 - (a) That he is not less than nineteen years of age; and
- 35
- (b) That he has had such training and passed such examinations as the Board may from time to time require.

(5) Notwithstanding anything to the contrary in subsection two of this section, the Board may, for a period not exceeding four years after the date of the commence-

40 ment of this Act, accept such experience as it may consider to be equivalent to experience as an apprentice as if it were experience as an apprentice for the purpose of registration as an electrical serviceman.

(6) For the purposes of subsection two and subsection three of this section the Board may accept experience gained by a person in assisting to do electrical wiring work with the permission of the Board granted under subsection two of section twenty-one of this Act 5 as if it were experience as an apprentice.

(7) In addition to the persons entitled to be registered under the foregoing provisions of this section, the Board may, on application made at any time after the expiry of a provisional licence issued under sub- 10 section one or subsection two of section sixteen hereof, grant registration as an electrician or registration as an electrical serviceman or limited registration to the person to whom the licence was issued if the Board is satisfied that the applicant has had not less than the 15 experience prescribed by this section in the class or classes of work in respect of which he has applied for registration and that, during the currency of the licence, he has satisfactorily performed the work of an electrician or of an electrical serviceman or of a holder of limited 20 registration, as the case may be.

(8) In computing for the purposes of registration under this Act the period during which any person has been employed or engaged in the class of work for which registration is desired, any time occupied or any experi- 25 ence gained by the person while he was employed or engaged in contravention of the provisions of this Act shall not be taken into account.

12. (1) Notwithstanding anything to the contrary in section eleven of this Act, every person who was 30 registered as an electrical wireman under the Electrical Wiremen's Registration Act 1925 immediately before the commencement of this Act and was not then limited in respect of the electrical wiring work which he could carry out or the premises in connection with 35 which he could carry out electrical wiring work, and every person who was entitled immediately before the commencement of this Act to be re-registered as an electrical wireman under subsection three of section thirteen of that Act without being limited as aforesaid, 40 on making application to the Board within one year after

(b) If he is not entitled to be registered under this Act as an electrician, be entitled to be granted a provisional licence to carry out the work of an electrician until such time as he qualifies for registration as an electrician.

(2) Where any person was registered as an electrical wireman under the Electrical Wiremen's Registration See Reprint Act 1925 immediately before the commencement of this vol. III, p. 73 Act and was then limited in respect of the electrical

- 25 wiring work which he could carry out or the premises in connection with which he could carry out electrical wiring work, the Registrar shall register that person under this Act either as an electrical serviceman or as a holder of limited registration, whichever the
- 30 Board considers to be comparable with the person's previous registration; and it shall not be necessary for the person to apply to be so registered or to pay any additional fee for the registration.

(3) Where any person was entitled immediately 35 before the commencement of this Act to be re-registered as an electrical wireman under subsection three of section thirteen of the Electrical Wiremen's Registration Act 1925, but on re-registration would have been limited in respect of the electrical wiring work which he 40 could carry out or the premises in connection with which

he could carry out electrical wiring work, and that person

- (a) That he is a registered electrician or is registered under the Engineers Registration Act 1924 as an electrical engineer; and
- (b) In the case of a registered electrician, that he has been employed or engaged in electrical 20 wiring work for at least five years after being registered either as an electrical wireman under the Electrical Wiremen's Registration Act 1925 or as an electrician under this Act and is the holder of a registration certificate as an 25 electrician free from endorsement; and
- (c) In the case of an electrical engineer, that he is not for the time being suspended or disgualified from doing the work of a registered electrician; and
- (d) That he is not less than twenty-five years of age; and
- (e) That he is a fit and proper person to inspect and test electrical wiring work and is competent to do so. 35

(2) Every person who was registered as an Inspector of electrical wiring under the Electrical Wiremen's Registration Act 1925 immediately before the commencement of this Act shall be deemed to be registered as an Inspector of electrical wiring under this Act.

(2) As soon as practicable after the receipt of any such application the Board shall consider the application and shall give such directions in respect thereof as it thinks fit.

- (3) In connection with any such application, the 10 Board may, if it thinks fit,---
 - (a) Examine on oath or otherwise the applicant, or any person objecting to the application, or any other person, with respect to the application; and for the purposes of this paragraph the Chairman of the Board may administer an oath to any person:
 - (b) Appoint some competent person or authority to inquire and report to it as to the training, experience, and qualifications of the applicant, or any matter connected with the application:
 - (c) Receive any evidence which it thinks fit (whether on oath or otherwise); and act on any document, report, information, statement. matter, or recommendation which in its opinion may assist it to deal with the application:
 - (d) Require any person to verify by statutory declaration any statement made by him with respect to any application, or with respect to any objection to an application.

(4) If the Board, after considering any application as aforesaid, is of opinion that the applicant is entitled to be registered under this Act in accordance with his application, it shall so direct, and the Registrar 35 shall thereupon register the applicant, and shall notify

him accordingly.

(5) If the Board, after considering any application as aforesaid, is of opinion that the applicant is not entitled to be so registered, it shall direct accordingly,

40 and the Registrar shall thereupon refuse to register the applicant, and shall notify him accordingly.

(6) No entry in any register of the name of any person shall be made by the Registrar without the direction in writing of the Board.

(7) Where the registration of any person is authorized pursuant to this section, the Registrar shall 5 enter in the appropriate register such particulars with respect to the person as may be prescribed, including a statement of any limitations subject to which the registration has been authorized, and a like statement shall appear in every certificate of registration issued 10 under this Act in respect of the person so registered.

(8) Every person registered under this Act shall be entitled to receive a certificate of registration under the hand of the Registrar. Every such certificate shall remain the property of the Board, and shall be 15 surrendered as required under this Act or on demand by the Registrar in writing.

15. (1) The Board may direct that the registration of any person as an electrical serviceman shall be restricted to a prescribed class or classes of work. 20

(2) The Board may direct that the registration of any person who is being granted limited registration shall be limited in one or more of the following respects, namely:—

- (a) That he shall be limited to such work as the 25 Board may specify:
 - (b) That he shall be limited to work only on specified premises:

- (2) The Board may grant to any person, on payment 15 of the prescribed fee, a provisional licence to carry out any specified electrical wiring work for a period not exceeding twelve months at any one time, and while the licence remains in force the holder thereof shall be entitled to carry out such work as may be specified in 20 the licence.
 - (3) The Registrar may, on receipt of the prescribed fee and with the approval of any two members of the Board, grant to any applicant for registration as an electrician or as an electrical serviceman or for limited
- registration an authority to carry out such electrical 25wiring work as may be specified by the Registrar pending the determination of the Board with respect to his application:

Provided that no such authority shall be granted by 30 the Registrar unless the applicant produces satisfactory evidence that he has had not less than the period of experience specified in section eleven hereof in the class of work for which the authority is required.

(4) Any such licence or authority may at any time 35 during the currency thereof be withdrawn by the Board.

- (e) He has, in the opinion of the Board, carried out or caused to be carried out electrical wiring work in a negligent, unsatisfactory, or incom- 20 petent manner, or in a manner contrary to any Act or regulations relating to electrical supply or electrical wiring work which was in force at the time the work was done; or
- (f) He has culpably or negligently created a risk to 25 life or limb or has caused a serious fire hazard through having used or caused to be used faulty or improper materials; or
- (g) He has wilfully deceived or attempted to deceive any Inspector of electrical wiring by purposely 30 concealing inferior work or inferior materials used as part of any electrical installation, or by making any false or misleading statement (whether in writing or not) to any such Inspector; or 35
- (h) He has neglected to furnish any return required under any Act or regulation relating to electrical wiring work or has furnished a false return; or
- (i) He has employed, instructed, or permitted any 40 unauthorized person to do any electrical wiring work; or

- (j) He has two or more endorsements made on his registration as hereinafter certificate of provided: or
- (k) Being restricted or limited in respect of the electrical wiring work which he may do, it is proved to the satisfaction of the Board that he has done electrical wiring work which he is not authorized to do; or
- (l) He is no longer employed in the situation to which his registration applies; or
- (m) His name is transferred to any other such register on his becoming entitled to the transfer.
- (2) The Board shall cause the name of any person
- 15 to be removed from the register of Inspectors of electrical wiring if-
 - (a) He ceases to be employed by the Electrical Supply Authority in respect of which he was last registered as an Inspector of electrical wiring; or
 - (b) The Board so determines under section twentyeight or section twenty-nine of this Act; or
 - (c) He is no longer registered either under this Act as an electrician or under the Engineers See Reprint Registration Act 1924 as an electrical engineer; vol. 1, p. 381

(d) In the case of a person who is registered under the Engineers Registration Act 1924 as an electrical engineer, he is for the time being suspended or disqualified from doing the work of a registered electrician.

(3) In addition to the powers conferred on it by the foregoing provisions of this section, the Board may cause to be removed from any register the name 35 of any person who fails, within the time limited in that behalf by a notice served on him by the Board, to notify the Board that he continues to be engaged in the calling of a person registered under this Act or that, though not so engaged,

(2) In any prosecution for an offence against this Act, a certificate under the hand of the Registrar to the 35 effect that the defendant is not registered or is not the holder of a provisional licence under this Act or of an authority under this Act, or to the effect that his registration is suspended or is not in force, or to the effect that any person has failed or refused to surrender 40 any certificate or licence on demand by the Registrar in writing, shall, in the absence of proof to the contrary and where the fact is in issue, be sufficient evidence of any such fact which is stated in the certificate.

(3) In any such prosecution, judicial notice shall be taken of the signature of the Registrar on any such certificate, licence, or authority.

(4) In any prosecution for an offence against this 5 Act, where any electrical wiring work has been done on any premises and the person who was the occupier of the premises at the time the work was done has refused or failed, on demand by an Inspector of electrical wiring or other person duly authorized to inspect electrical

- 10 wiring work, to give to the Inspector or authorized person any information at his disposal that may lead to the identification of the person who has done the electrical wiring work, that occupier shall, unless the contrary is proved, be deemed to have permitted the
