A BILL INTITULED

An Act to constitute the Eltham County.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows :---

1. The Short Title of this Act is "The Eltham County Act, Short Title. 1906."

2. (1.) The Eltham County is hereby constituted, and shall com- Constitution of Eltham County. prise all-those-portions that portion of the Hawera and-Stratford-Coun-10 ties-already-constituted under "The Counties-Act, 1886," County par-

ticularly described in the *First* Schedule hereto. and-the-boundaries-of the-Hawera-and-Stratford-Counties-are-hereby-altered-accordingly.

(2.) The boundaries of the Hawera County so altered are Jurisdiction of 15 particularly described in the Second Schedule hereto.

3. From and after the coming into operation of this Act, and during the existence of the county so constituted, no local authority other than the Eltham County Council shall, within the limits of the said county, exercise any jurisdiction or authority over any roads or

20 over or in relation to any matter or thing in respect of which jurisdiction is conferred upon a County Council under the provisions of "The Counties Act, 1886," or any amendments thereof, or otherwise :

New proviso.

Provided that nothing herein shall limit the power of the Merger of portion of 25 Governor at any time to proclaim a town district in the said county.

- 4. (1.) So much of the Waimate Road District as is included within the boundaries of the county constituted by this Act is hereby declared to be merged in that county.
- (2.) The remaining portion of the said road district shall be 30 deemed to be a road district whose boundaries have been altered by the formation of a new district under "The Road Boards Act, 1882."

5. (1.) The preceding provisions of this Act shall take effect on a day to be fixed by the Governor by notice in the *Gazette*.

(2.) Such notice shall not be gazetted until after a proposal that the Act shall come into operation has been submitted in the manner prescribed by "The Local Elections Act, 1904," to the ratepayers within the proposed new county, and such proposal has been duly carried.

(3.) At the poll on such proposal each ratepayer shall have one vote only.

(4.) It shall be the duty of the Hawera County Council within 10 three months after the passing of this Act to take a poll as aforesaid.
