A BILL INTITULED

An Act for the Adjustment of the Boundaries of Education Districts on the Title. Constitution of New Counties.

BE IT ENACTED by the General Assembly of New Zealand in Parliament 5 assembled, and by the authority of the same, as follows:

1. The Short Title of this Act is "The Education Districts Act, 1882."

Short Title.

2. "Education District" and "District" respectively mean an Education Interpretation.

District constituted under "The Education Act, 1877.

3. Where the boundaries of any county comprised in an Education District Redefinition of 10 are altered by the creation of a new county, then, and in any such case, if the Education Districts, or constitution of new county and the remaining part or parts of the county or counties from new counties therein. which it has been severed,-

- (1.) Are all comprised within the same Educational District, then such new county shall be, and be deemed to be, as and from the date of its constitution, included within and form part of the district wherein are comprised the county or counties from which it has been severed:
 - (2.) Are partly in one district and partly in another, or others, then the Governor, by Order in Council, may redefine any of such lastmentioned districts, and may declare in which of such districts shall be comprised the new county or any part thereof.

4. The County of Hawera is hereby declared to be, and shall be deemed to County of Hawera have been, as and from the date of the constitution thereof, comprised within deemed to be in Wanganui Education the Education District of Wanganui.

- 5. The Education Board of the District of Wanganui, and every member of Wanganui Education 25 such Board, and all other persons whomsoever acting under the powers and Board indemnified authorities of "The Education Act, 1877," are hereby, each and every of them, relation to new indemnified, freed, and discharged from and against all penalties whatsoever (if any) incurred by them, or any or either of them, for or by reason of any act, matter, or thing done, made, or authorized by them, or any or either of them, under 3() the powers aforesaid, within that part of the Education District of Wanganui now forming the County of Hawera, from and since the date of the constitution of the said county.
- 6. In case any action, suit, or prosecution of any nature whatsoever General issue may shall be brought against them, or any or either of them respectively, for or on be pleaded and this 35 account of any penalty whatsoever incurred, or to be incurred, for or by reason evidence. of any infringement of the aforesaid Act, they or he may plead the general issue, and upon their defence give this Act and the special matter in evidence upon any trial to be had thereupon.
