A BILL INTITULED

An Act to continue the Operation of certain Expiring Enactments. Title. BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows:

1. This Act may be cited as the Expiring Laws Continuance short Title. Act, 1918.

2. So much of the enactments mentioned in the Schedule operation of hereto as are for the time being unrepealed shall continue in force expiring enactments 10 until the thirty-first day of August, nineteen hundred and nineteen, continued. and shall then expire, unless further continued.

3. (1.) Part I of the Monopoly Prevention Act, 1908, is hereby Part I of revived as from the commencement of the thirty-first day of Prevention Act, December, nineteen hundred and fifteen, and shall be deemed to 1903, revived. 15 have been in force on and after that date accordingly, and shall continue in force until the thirty-first day of August, nineteen

hundred and nineteen, and shall then expire unless further continued. (2.) The Monopoly Prevention Amendment Act, 1913, is hereby Repeal. repealed.
