A BILL INTITULED

AN ACT to extend the Powers of the Egmont National Park Board. Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Egmont National Park Act, 1901," and it shall form part of and be read together with "The Egmont National Park Act, 1900" (hereinafter referred to as "the principal Act"). Short Title.

2. (1.) Notwithstanding anything in the principal Act, it shall be lawful for the Board to issue licenses for all or any of the purposes following, that is to say,— Power to issue certain licenses.

- (a.) To cut and remove dead timber only;
- (b.) To win and remove stone or gravel for ballast or for metal-ling roads;
- (c.) To construct and use tramways for the removal of any such timber, ballast, or road-materials.

(2.) The Board may from time to time make by-laws under the principal Act prescribing— By-laws.

- (d.) The form of such licenses;
 - (e.) The conditions under which such licenses shall be issued;
- and
- (f.) The fees payable on any such license.

New clauses.

3. The Minister for Railways may win and remove stone for ballast, building-stone, and stone for protection-works and other railway purposes, on such part of the Egmont National Park as may be agreed on between the said Minister and the Board, and may construct and work a line of railway to that part of the said park for the purpose of such removal. Minister for Railways may quarry stone.

Board may lease
certain land.

4. With the consent of the Governor the Board may lease to adjoining occupier of land the open land described in the Schedule, on such terms as to area, rent, and other conditions of occupation and improvement as the Board, with the consent aforesaid, may think fit.
