### A BILL INTITULED

#### **An Act to facilitate the export of sheep and cattle for slaughter**

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

**1. Short Title**—This Act may be cited as the Export of Sheep and Cattle for Slaughter Act 1984.

**2. Interpretation**—In this Act “consent” means any authorisation, permission, licence, permit, and any other approval of any sort that is required by or under the Customs Act 1966, the Shipping and Seamen Act 1952, or any other enactment, for the export of sheep or cattle for slaughter.

**3. Consent to export of sheep or cattle for slaughter**—No consent required for the export of sheep or cattle for slaughter shall be withheld, nor shall any condition or requirement be attached to any such consent, solely or principally on the ground of the economic or industrial relations impact of any such export on the whole or any part of the livestock slaughter industry in New Zealand.

### A BILL INTITULED

#### **An Act to facilitate the export of sheep and cattle for slaughter**

BE IT ENACTED by the General Assembly of New Zealand  
5 in Parliament assembled, and by the authority of the same. as follows:

**1. Short Title**—This Act may be cited as the Export of Sheep and Cattle for Slaughter Act **1985**.

**2. Interpretation**—In this Act, the term “consent” means  
10 any authorisation, permission, licence, permit, and any other approval of any sort that is required by or under the Customs Act 1966, the Shipping and Seamen Act 1952, or any other enactment, for the export of sheep or cattle for slaughter.

**3. Consent to export of sheep or cattle for slaughter**—  
15 (1) Subject to **subsection (2)** of this section, no consent required for the export of sheep or cattle for slaughter shall be withheld, nor shall any condition or requirement (other than any reasonable condition or requirement imposed for the welfare of the sheep or cattle during carriage) be imposed in respect

of any such consent or export, solely or principally on the ground of the economic or industrial relations impact of such export on the whole or any part of the livestock slaughter industry in New Zealand.

(2) **Subsection (1)** of this section applies in respect of any proposed export of sheep or cattle for slaughter only where— 5

(a) The person seeking the consent proposes to export the sheep or cattle on or before the 30th day of April 1987; and

(b) There is a reasonable likelihood that, if the necessary consents are granted, the export will occur on or before that date. 10
