This Public Bill originated in the Legislative Council, and, having this day passed as now printed, is transmitted to the House of Representatives for its concurrence.

## A BILL INTITULED

An Act to validate the Title to certain Reserves apportioned under Title. "The Education Reserves Act, 1877."

WHEREAS the arbitrators respectively appointed under "The Preamble. 5 Education Reserves Act, 1877," have made their awards, which have from time to time been publicly notified in the New Zealand Gazette: And whereas an error has occurred in the publication of their award in the Gazette of 12th June, 1878, relating to the lands at Puhoi Bush and Puketoi respectively, in the Provincial District of Hawke's

10 Bay, and another error has also occurred in their award relating to the Reserve No. 1,400, in the Provincial District of Canterbury; and it is expedient to rectify the errors aforesaid: And it is expedient to validate the said awards respectively, and to declare the legal estate in the lands apportioned thereunder:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same,

1. The Short Title of this Act is "The Education Reserves short Title. Act Amendment Act, 1890."

2. Title may issue for part of Reserve No. 1,400 to Timaru High School Governors.

Antevesting date. Grant of right of way. 3. With respect to part of Reserve No. 1400, which in the aforesaid Gazette of 12th June, 1878, was intended to be allocated for the purposes of secondary education, the District Land Registrar of Canterbury is hereby authorised and required to issue a certificate of title for the lands comprised in Lot 2 on a plan deposited in the Lands Registry Office at Christchurch as No. 859, and containing by admeasurement four hundred and ten acres one rood and thirty-four perches (more or less), being the aforesaid part of Reserve No. 1400, for an estate in fee-simple, vested, as from the 5th March, 1879, by notification in the Gazette, in the Board of Governors of the Timaru High School, established under "The Timaru High School Act, 1878," for the maintenance of the said school.

To give access to the aforesaid lands, the School Commissioners for the Canterbury Provincial District hereby give a right of way over the road to the north-east of Lot 2 of the aforesaid Deposit 15 Plan No. 859; and the description of the land included in the right-

of-way shall be as follows, namely,—

A piece of land situate in Block XVI. of the Geraldine Survey District, part of Reserve No. 1,400 (in red), commencing at the eastern extremity of Lot 2 on a plan deposited in the Lands Registry Office at Christchurch as No. 859, and running thence north-westerly along the northern boundary of the said lot, and intersecting Part d of Lot 1 on the said plan, to Rolleston's Road; which piece of land is of the uniform width of one chain, and is part 25 of the land in certificate of title, volume 106, folio 279.

The aforesaid Registrar is hereby authorised to cancel the certificate of title heretofore issued to the School Commissioners of the Provincial District of Canterbury for the Reserve No. 1,400, containing one thousand eight hundred and thirty-eight acres, and in 30 lieu thereof shall issue a new certificate of title to the said Commissioners for the area of the aforesaid Reserve No. 1,400 as affected by this Act.
