A BILL INTITULED

AN ACT to amend the Education Reserves Act, 1908.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows :---

1. This Act may be cited as the Education Reserves Amend- short Title. ment Act, 1911, and shall form part of and be read together with the Education Reserves Act, 1908 (hereinafter referred to as the principal Act).

2. (1.) The Trustees of a high school under the principal Act Leasing-powers of High School 10 may grant leases of any lands vested in them.

(2.) All such leases shall be subject to the provisions of the Public Bodies' Leases Act, 1908, and the Trustees of every such school, are hereby declared to be a leasing authority within the 15 meaning of that Act.

(3.) Notwithstanding the provisions of section three of the Public Bodies' Leases Act, 1908, the powers of leasing hereby conferred upon the Trustees of high schools may be validly exercised, notwithstanding any restriction or limitation of leasing-powers imposed by 20 any other Act in force at the passing of this Act.

(4.) All rents derived from any such lease shall from time to time be paid into the proper fund and be appropriated thereout for the purposes to which the annual income of the Trustees is for the time being properly applicable.

3. Section eleven of the principal Act is hereby amended by Section 11 of 25 omitting from subsection one the words "lease and," and the words principal Aot "lease or"; and by omitting from subsection two the words "rents" and." the words "lease or," and the words " annual income or."

4. Section twelve of the principal Act is hereby repealed.

5. The Governor may, on the recommendation of the Land Board of the district in which are situated any reserves or endowments vested in the Crown by or in pursuance of section two of the Education Reserves Amendment Act, 1910, set apart as sites for public schools, secondary schools, or technical schools any part of such reserves or endowments.

6. No transfer, sublease, or mortgage executed after the passing of this Act of any lease of an education reserve or endowment, or of any part thereof, shall be valid until and unless the written consent 10 thereto of the Land Board administering that reserve or endowment has been obtained.

7. Section two of the Education Reserves Amendment Act, 1910, is hereby amended by inserting after the word "prescribed," in subsection six, the words "and also the expenses incurred by the Board 15 for the maintenance and upkeep of the said reserves and endowments.'

8. Section six of the Education Reserves Amendment Act, 1910, is hereby amended by omitting the words "to the credit of the Lands and Survey vote," and substituting therefor the words 20 "and form part of the Consolidated Fund."

9. Section six of the Education Reserves Amendment Act, 1910, is hereby further amended by adding thereto the following subsections :---1. 18214. 1

"(3.) The expenses incurred by the Board for the maintenance 25 and upkeep of the reserves and endowments administered by it shall be deducted from the revenues by the Receiver of Land Revenue, and shall be paid by him into the Public Account, and shall form part of the Consolidated Fund.

"(4.) For the purposes of this section the term 'maintenance' 30 includes the payment of insurance premiums."

10. (1.) The Board shall charge such fees for the preparation and approval of leases and for the approval of transfers, subleases, and mortgages in respect to the reserves and endowments administered by it as the Governor in Council by regulations in that behalf from 35 time to time prescribes.

(2.) All such fees shall be paid into the Public Account and shall form part of the Consolidated Fund.
