BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority

- 1. This Act may be cited as the Emergency Regu- short Title. 10 lations Continuance Act, 1947, and shall be read together with and deemed part of the Emergency Regu- 1939, No. 8 lations Act, 1939 (hereinafter referred to as the principal Act).
- 2. The enactments specified in the First Schedule Repeal of 15 hereto are hereby repealed to the extent indicated in provisions for making that Schedule:

Provided that the repeal of those enactments or of any of them shall not affect the validity of any of the regulations specified in the *Second* Schedule hereto, or the power and authority of the Governor-General in Council to amend or extend those regulations under this Act.

3. The emergency regulations specified in the *Second* Schedule hereto, unless they are sooner revoked by the Governor-General in Council, shall continue in force until the thirty-first day of December, nineteen hundred 10 and forty-eight, and shall then expire.

4. The Governor-General may from time to time, by Order in Council, amend or extend any of the regulations specified in the *Second* Schedule hereto for the purpose of giving full effect to the intent and purport 15 of those regulations, but not further or otherwise, and the principal Act shall apply to any amendment or extension in the same manner as it applies to the said regulations.

5. All emergency regulations heretofore made under 20 the principal Act (including regulations made under the joint authority of that Act and any other Act) shall for all purposes be deemed, as from the making thereof, to have been made with full power and authority, and to be and to have been valid and of full effect; and the 25 powers, rights, duties, and liabilities of all persons in respect of all things done or suffered, whether before or after the passing of this Act, shall be determined accordingly.

6. All emergency regulations in force immediately 30 before the passing of this Act, other than the regulations specified in the *Second* Schedule hereto and the regulations specified in the Schedule to the Supply Regulations Act, 1947, are hereby revoked.
