A BILL INTITULED

An Act to amend the Factories Act 1946

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, 5 as follows:

- 1. Short Title—This Act may be cited as the Factories Amendment Act 1972, and shall be read together with and deemed part of the Factories Act 1946* (hereinafter referred to as the principal Act).
- 2. Limits of working hours—(1) Section 19 of the principal Act (as amended by section 2 (1) of the Factories Amendment Act 1956) is hereby further amended by omitting from paragraph (c) of subsection (1) the words "conditions

(2) The said section 19 (as amended by section 2 (2) of the Factories Amendment Act 1956) is hereby further amended by repealing subsections (2), (3), and (4), and substituting the following subsections:

"(2) Subject to the provisions of this Act, no person under the age of 16 years shall be employed in or about a factory—

"(a) At any time between the hours of 6 o'clock in the evening of any day and 7 o'clock in the morning of the following day; or

"(b) On any Sunday; or

"(c) On any holiday, except as may be provided in an award, industrial agreement, order, or determination referred to in subsection (1) of this section.

"(3) Except as provided in section 24 of this Act, no woman 20 who has attained the age of 16 years shall be employed in or about a factory at any time between the hours of 6 o'clock in the evening of any day and 11 o'clock in the morning of the following day unless at some time in that period she has a continuous rest interval of at least 11 consecutive hours 25 (of which at least 7 consecutive hours fall between the hours of 10 o'clock in the evening and 7 o'clock in the morning) during which she is not employed in or about the factory.

"(4) The rest interval of 11 hours referred to in subsection (3) of this section shall not begin after 11 o'clock in the 30 evening, except with the consent of an Inspector given after consultation with each organisation of employers and of workers concerned.

"(5) In giving his consent under subsection (4) of this section, an Inspector may impose such conditions, if any, as 35 he thinks fit.

"(6) Nothing in subsections (3), (4), and (5) of this section shall apply in respect of any factory in which the only persons engaged or employed are members of the same 40 family."

"(6) Subsections (3), (4), and (5) of this section shall not apply—

"(b) In respect of the employment of any woman in or about a factory—

"(i) In a responsible position of a managerial or technical nature; or

3. Prohibition and restrictions as to overtime—Section 20 of the principal Act (as amended by section 3 of the Factories 15 Amendment Act 1956 and section 5 of the Factories Amendment Act 1961) is hereby further amended by repealing subsection (2), and substituting the following subsection:

"(2) Subject to subsections (3), (4), and (5) of section 19 of this Act, and to subsections (1), (3), and (4) of this 20 section, the prescribed working hours or times may from time to time be extended."

4. Special provisions in case of certain factories—The principal Act is hereby further amended by repealing section 24 (as substituted by section 5 of the Factories Amendment Act 1956), and substituting the following section:
