# A BILL INTITULED

# AN ACT to rectify certain errors in "The Title. Gold Fields Acts Amendment Act. 1865."

WHEREAS it is expedient that certain errors in "The Gold Fields Acts Amendment Act 1865" should be rectified

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled and by the authority of the same as follows-

I. The Short Title of this Act shall be "The Gold Fields Acts short Title. Amendment Act 1866."

II. The following alterations shall be introduced into the said Schedules A. and B. cited Act and be read as if originally part thereof (1.) The Schedule hereto marked A. shall be substituted for the "Gold Fields Acts recited Act and be read as if originally part thereof

- Schedule to the said Act marked A. The Schedule hereto Amendment Act 1865." marked B. shall be substituted for the Schedule in the said last-mentioned Act marked B. and wherever in the said Act the Schedule thereto marked A. or the form therein is mentioned or referred to the said Act shall be taken and deemed to refer to the Schedule hereto marked A. or the form therein as the case may be and wherever in the said Act the Schedule thereto marked B. or the form therein is mentioned or referred to the said Act shall be taken and deemed to refer to the Schedule hereto marked B. or the form therein as the case may be.
- (2.) In the first sub-section of the eighteenth section to the said Act the words "copies of" shall be omitted and the word "fourteen" shall be omitted and in place of the word "fourteen" shall be substituted the word "thirty."

III. The thirty clear days within which under the said Act Periods defined within objections may be entered against the construction of any water- construction of races race shall with respect to the persons whose interests may be affected may be lodged. by the diversion of water and with respect to the owners or occupiers of land through which it is proposed to carry the water-race date from the day of the delivery to such persons respectively of a notice in the form contained in Schedule A. hereto provided that no license

shall be granted under the eighteenth section of the said Act by the Warden until the expiration of thirty days from the delivery to him of a notice in the form contained in the said Schedule A. to this Act nor unless he shall be satisfied that a notice in the said form has been posted and kept posted in the manner required by the said Act.

Prior notices to deemed invalid. IV. All notices posted and licenses issued in accordance with the forms contained in the Schedules to this Act prior to the passing of this Act shall be deemed and taken to have been validly posted and issued respectively and shall have the like effect as if the forms in the Schedules to this Act had been originally contained in the Schedules to the said Act.
