Commentary

Recommendation

The Finance and Expenditure Committee has examined the Government Superannuation Fund Amendment Bill and recommends by majority that it be passed with the amendments shown.

Introduction

The Government Superannuation Fund Amendment Bill, as introduced, amends the Government Superannuation Fund Act 1956 (the principal Act) by creating a new Crown entity, GSF New Zealand (GSFNZ), to manage the Government Superannuation Fund (the fund) and administer the fund schemes. It sets out a new regime for investment of the fund, specifies the roles of the Minister of Finance and GSFNZ, and provides for the Minister of Finance to give certain directions to GSFNZ on investment of the fund. It also requires that such directions must be consistent with GSFNZ's obligation to manage the fund on a prudent commercial basis, consistent with best-practice portfolio management.

The objective of this bill is to improve the Government Superannuation Fund assets income from investments, reducing the annual cost to the Crown of financing the stream of GSF benefits, without incurring undue risk. It is important to note that this legislation does not impact on the benefits of pensioners. Employees will, after the passage of this bill, still contribute the same amounts as prior to this bill, and will retain the same entitlements and rights. This bill will simply improve the structures for investing the assets of the GSF.

This commentary addresses the major issues we focused on and outlines the amendments we recommend.

Name of the Crown entity

Concerns were raised in submissions that the name of the new Crown entity might lead to confusion both with New Zealand Superannuation and between the different bodies involved in administering the fund. In particular, the distinction may be unclear between the Crown entity ("GSF New Zealand"), the Board of the entity ("the GSF New Zealand Board"), and the fund assets managed by the entity ("the Government Superannuation Fund").

We recommend that the proposed new section 14(1) (in clause 7(1)) be amended by changing the name of the Crown entity to "Government Superannuation Fund Authority", with all consequential changes in the bill. We believe this will avoid confusion with New Zealand Superannuation by not using the words "New Zealand". It will also satisfactorily distinguish between the various bodies involved in the GSF. To reflect this change, for the remainder of this commentary, we will refer to the Crown entity as "the Authority", rather than "GSFNZ".

Transition of functions between the Ministry of Economic Development and the Authority

Currently, the Ministry of Economic Development (MED) administers the fund. The GSFNZ Establishment Board considers that it would be useful if we amend clause 2(2) to allow a period of time between the appointment of the board of the Authority and the Act coming into force. This will give the board of the Authority time to consider the Establishment Board's recommendations, enter contracts, and make transitional arrangements. This requires that the board of the Authority's contracting powers come into force on the date this Act receives the Royal assent and the remainder of the bill comes into force 42 days after its enactment. The majority recommends amendments to clauses 2(2) and 2(3) to give effect to these proposals.

Joint venture

The bill allows the Authority to enter into shared service arrangements with either another fund or superannuation scheme, provided these are Crown-managed or a Crown entity. It also permits the Authority to enter into a shared services arrangement by establishing a subsidiary.

The GSFNZ Establishment Board recommended that the most appropriate arrangements for managing and administering the fund and GSF schemes would be for the Authority to form a joint venture with the National Provident Fund (NPF) to provide shared services for secretariat functions. Other Crown organisations may wish to enter into that joint venture company in the future.

However, a joint venture was not contemplated in the bill as introduced. Therefore, the bill does not enable the Authority to establish a joint venture company, and the National Provident Fund Restructuring Act 1990 (NPF Restructuring Act) similarly prevents the NPF from forming a joint venture. The majority recommends that the bill be amended to allow such a joint venture to occur. This amendment will support the policy intent of the bill.

This would require a number of amendments to the proposed sections 14A, 14B, and 19(1) in clause 7(1), and to clause 38 of proposed Schedule 4 in Schedule 1.

Incorporating clauses of the New Zealand Superannuation Bill into this bill

We have recently been considering the New Zealand Superannuation Bill (NZ Super Bill). The NZ Super Bill and the Government Superannuation Fund Amendment Bill are similar in that they codify how a Crown financial institution should manage large funds of financial assets. We heard a number of submissions suggesting that particular clauses in the NZ Super Bill relating to the management of these funds should be incorporated into this bill. In particular, there is interest in including provisions relating to ethical investment and provisions increasing transparency and accountability in reporting the performance of both the fund and the Crown entity in this bill.

After examining this matter, we believe that it is appropriate to incorporate clauses 50, 55(a), 58(2), 59, 60, 61, 65, 68, and 71 of the NZ Super Bill, suitably amended, into this bill. We would effect this in a number of ways. The majority recommends:

The National minority is concerned by the incorporation of these clauses from the New Zealand Superannuation Bill into the Government Superannuation Fund Amendment Bill. They result in conflicting objectives for the management of the fund which the Treasury acknowledged was unwise.

Issues relating to the statement of policies

Amendment to principal Act

Section 19F of the principal Act requires a statement of policies to be published. Those policies relate to the exercise of the discretionary powers referred to in section 19E of the principal Act. Clause 8 of the bill repeals section 19F, and substitutes a new section which requires the Authority, when exercising its discretionary powers in relation to the schemes, to act in accordance with the published statement of policies. A number of issues arise out of this amendment. These are outlined below.

Exercising of discretionary powers

We consider that it is possible the proposed section 19F(1)(a) (in clause 8) is too restrictive in its wording. If situations arise that do not easily fall within the statement of policies, it would be preferable that the Authority not be strictly bound to the statement of policies.

We recommend that clause 8, proposed section 19F(1)(a) be amended by adding the words "unless the Board considers it inappropriate to do so, given the particular circumstances of a case". We believe this change will require the Authority and the Appeals Board to act in accordance with the statement of policies when exercising their discretionary powers. However, it will still allow sufficient flexibility to consider cases on their individual merits and to move outside these policies in circumstances where the policies are not appropriate or do not cover a particular case.

Publication and changes to the statement of policies

At present, there are no provisions specifying how the statement of policies is to be published. We recommend that a provision be introduced into the bill requiring the Authority to publish the statement, or republish it if changes are made to it, in whatever manner the Authority considers appropriate.

The proposed section 19F(2), inserted by clause 8, provides for the statement of policies to be changed. Under paragraph (a), the Authority is required to take into account the interests of any person who has an interest in the matter prior to making any changes. These interested parties include (but are not limited to) the Crown, and any other contributor, beneficiary or controlling authority. A similar provision in clause 6, proposed section 12(a), requires the Appeals Board to take into account the interests of any person who has an interest in any matter that is the subject of appeal. Both of these clauses are limited to those interests that are known by the Authority or the Appeals Board.

Various submitters raised concerns that this bill provides insufficient protection for interested parties. In particular, they are concerned that there is no explicit requirement for consultation, which gives rise to a potential for the statement of policies to be changed without consultation. Submitters were particularly interested in requiring consultation with contributors and beneficiaries before amendments to the statement of policy can be made.

We agree that consultation should be undertaken before changing the statement of policies. We also consider consultation should be extended beyond contributors and beneficiaries to include other organisations that are representative of any people that may have an interest in the change. We recommend that clause 6, proposed section 12 and clause 8, proposed section 19F(2)(a) be amended to include such a requirement.

Requiring medical certificates for the surrender of a portion of an allowance

Once contributors are eligible to receive a retiring allowance, the contributor has an option under section 91B of the principal Act to surrender a portion of the retiring allowance in return for a payment of an allowance to another person. The amount to be paid is based on an actuarial assessment. This ensures that there is no overall increase or decrease in the liabilities of the fund. However, there is no requirement in the principal Act for people to demonstrate their health status before making such an election, which can lead to inaccurate assessments. There is a possibility of contributors with a low life expectancy making a section 91B election. This can mean that such elections are not fiscally neutral as required by the principal Act, and may be substantially disadvantageous to the fund.

We recommend that amendments be made by introducing a new clause 16A. This will amend section 91B to provide for the presentation of medical certificates when an election is made. This change will allow the correct actuarial value to be placed on the sum surrendered, and will ensure that such allowance payments will be fiscally neutral.

We note that this change will also be consistent with section 48 of the principal Act, which allows an election to surrender current benefits in favour of payments to a spouse or dependent following the contributor's death. Subsection (6) provides that such an election cannot occur until medical evidence has been obtained about the health of the contributor.

Repeal and replacement of provisions

Clause 7(1) currently provides for sections 14 and 15 of the principal Act to be repealed. Section 14 deals with contributions and other monies that are to be paid into the fund. Section 15 similarly provides for monies to be paid out of the account. If these sections are repealed, there will be no explicit provision for money to be paid into or out of the fund, and the Board will have to rely on its general powers to use the fund in the manner it was intended. We recommend that clause 7(1) repeal sections 14 and 15 of the principal Act,

but that the provisions in those sections be re-enacted in proposed new sections 13A and 13B.

Minor amendments

We recommend that clause 26 be amended to ensure no tax liabilities upon the transition will arise as a result of the transfer of the GSF assets to the Authority.

We recommend that clause 30 be amended. Currently, this clause requires two sets of accounts and reports on matters affecting the Fund in the first year of operation, one by MED covering the period from 1 July 2001 to the date of enactment and another by the Authority covering the period from enactment until 30 June 2002. The proposed amendment will require the Ministry to prepare a report and accounts for the period between 1 July 2001 and the date that the Authority assumes responsibility for the Fund. This information will be amalgamated into the reports and accounts that the Authority will have responsibility for once the bill is enacted.

We recommend that a new clause 34A be introduced providing that employees who transfer from the Ministry of Economic Development to the joint venture company will not be entitled to technical redundancy.

Drafting issues

We recommend that a number of minor amendments be made to the bill, largely concerned with technical drafting issues, clarifications of uncertain areas, or consequential amendments resulting from other changes being recommended.

Green Party minority view

The Green Party does not support the change in structure of the Government Superannuation Fund or the change in investment policy for this fund. We believe the fund is efficiently managed as part of the Ministry of Economic Development and does not need to be established as a new Crown entity with all the costs associated with that. Neither do we believe it is desirable for the fund to be able to invest on the sharemarket and invest off shore. We acknowledge that the current rate of return on investments is low on face value but point out these funds are primarily invested in fixed interest and other debt securities.

We believe such investments in Government activities, whether local or national, are therefore to some extent "internal" in that the low rate of return for the fund offsets the low cost to the borrowing arm of Government. Once the \$3.4 billion asset base of the fund starts to be invested in equities the cost of borrowing for the Government will increase. This is therefore an unacknowledged opportunity cost of the change in investment strategy.

We believe another opportunity cost is the greater risk associated with investing in equities. While in some years the return on investment will be greater than previously realised, in other years the return could be less or even negative. In such situations, because the fund contributes towards superannuation payments to members of the fund, tax revenue will need to be diverted to meet any shortfall on an annual basis. Therefore a hidden cost of commercialising the Government Superannuation Fund will be reduced certainty in planning the difference between benefits and revenue. Wild fluctuations in returns could significantly constrain other government activities.

In the same way the Green Party has highlighted the secondary status for ethical and socially responsible investing in the New Zealand Superannuation Bill. We submit that this bill should have placed "socially responsible" on the same basis as "prudent commercial". This applies both to investment criteria and reporting criteria. Equally we would like the Minister to require the Board members to take into account New Zealand's national interest and Government goals for sustainable development of New Zealand and performance in terms of social responsibility when making investment decisions.

Appendix

Committee process

The Government Superannuation Fund Amendment Bill was referred to the committee on 18 October 2000. The closing date for submissions was 15 December 2000. We received and considered 12 submissions from interested groups and individuals. We heard seven submissions orally. Hearing evidence took one hour 35 minutes and consideration took one hour 26 minutes.

We received advice from Treasury and the Government Superannuation Fund.

 - (a) the property and liabilities comprising the Fund held by 30 the custodian under section 19A of the principal Act; and
 - (b) the property and liabilities of the Superintendent that are connected with the Fund or schemes; and

- any other property or liabilities of the Crown, the (c) Superintendent, or a custodian arising from the investment of the Fund; and (d) any other property of the Crown used principally for the
- purpose of the Fund or schemes, including the whole of the leasehold interest in 2 floors of the building at 33 Bowen Street held in the name of the Government Superannuation Fund Department.
- (2)This section does not apply to any contract referred to in section 24.

24 Transitional provision relating to existing schemes administration contract

- Any contract entered into under section 19 of the principal Act (1)by the Minister in relation to the administration of the schemes before the commencement of this Act continues in 15 force according to its terms.
- (2) (GSFNZ) The Authority is appointed to act as the Minister's agent in relation to the contract.
- (3) Expenses incurred by the Crown under the contract are to be treated as if they were expenses incurred by (GSFNZ) the Authority for the purposes of section 14C of the principal Act.

25 **Records and registers**

- (1)Neither the Registrar-General of Lands, nor any other person charged with the keeping of any records or registers, is obliged solely by reason of this Act to change the name of the 25 custodian or the Superintendent or any other person to (GSFNZ) the Authority in those records or registers or in any document.
- It is sufficient proof, in the absence of evidence to the con-(2)trary, that property or any liability is vested in (GSFNZ) the 30 Authority if a person presents to a registrar or any other person an instrument, whether or not comprising an instrument of transfer,--
 - executed or purporting to be executed by (GSFNZ) the (a) Authority; and
 - relating to any property or liability held, immediately (b) before the commencement of this Act, by the custodian or the Superintendent or any other person; and

An employee of the Ministry of Economic Development who chooses to transfer to a company referred to in section 14A(5)(a) or (c) on terms and conditions of employment that are no less favourable than the terms and conditions of employment applying to the employee immediately before the transfer is not entitled to any payment or other benefit solely on the ground that-

- (a) the position held by the person in the Ministry has 10 ceased to exist; or
- (b) the person has ceased (as a result of the transfer to the new employer) to be an employee of the Ministry.

Past decisions

Past decisions 35

- All decisions made by the Government Superannuation (1)Appeals Board or the Superintendent or a former Government Superannuation Board or a Minister in favour of an individual contributor, beneficiary, or potential beneficiary have effect, in so far as they relate to that individual, as if the decision were one that that board or person was entitled to make.
- The decision binds (GSFNZ) the Authority in any dealings (2)after the (commencement of this Act) operative date with the contributor, beneficiary, or potential beneficiary in whose favour the decision was made, unless that person supplied 25 misleading or incorrect information or otherwise acted in bad faith.

51 Existing Government Superannuation Fund members

 Despite clause 50, a person who, immediately before becoming an employee of the board, was a contributor to the Government Superannuation Fund under Part II or Part IIA of the Government Superannuation Fund Act 1956 is, for the purposes of that Act, deemed to be employed in the Government service so long as that person continues to be an employee of the board; and that Act applies to that person in all respects as if that person's service as an employee of the board were Government service.
