A BILL INTITULED

AN ACT to constitute the Inglewood County.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as 5 follows :--

1. This Act may be cited as the Inglewood County Act, 1918.

2. The Inglewood County is hereby constituted, and shall com- Inglewood County prise all that area being portions of the Taranaki and Stratford constituted. Counties particularly described in the First Schedule hereto.

3. The boundaries of the said Taranaki and Stratford Counties Alteration of 10 are hereby altered accordingly.

4. The Moa Road District is hereby abolished, and shall be Stratford Counties. deemed to be merged in the said Inglewood County, and the pro- Moa Road District visions of section thirty-six of the Counties Act, 1908, shall apply abolished. 15 accordingly.

5. From and after the coming into operation of this Act no local Jurisdiction authority other than the Council of the Inglewood County shall within the limits of the said county exercise any jurisdiction or authority whatsoever over any roads or over or in relation to any 20 matter or thing whatsoever in respect of which jurisdiction is con-

ferred upon County Councils under any Act:

Provided that nothing herein shall affect the power of the Governor-General to proclaim any portion of the said county a borough, town, or other district.

Tarurutangi Registration District, Block XI, Paritutu Survey District, to the King Road; thence northerly by the west side of the King Road to a point in line with the northern boundary of Section 49, Tarurutangi Registration District, Block XI, Paritutu Survey District; thence across King Road to the north-west corner of said Section 49; thence easterly by the northern boundary thereof to the south-west corner of Section 53, Tarurutangi Registration District, Block XI, Paritutu Survey District; thence northerly and easterly by the west boundary and north boundary produced of said Section 53 to the east side of Hursthouse Road; thence southerly by the east side of Hursthouse Road to the north-west corner of Section 54, Tarurutangi Registration District, Block XI, Paritutu Survey District; thence north-east by the north boundary of said Section 54 to the west boundary of Section 199, Huirangi Registration District, Block XI, Paritutu Survey District; thence southerly and easterly by the west boundary and south boundary of said Section 199 produced across Mountain Road and Mountain Road and Railway Reserves to the west boundary of Section 99, Huirangi Registration District, Block XI, Paritutu Survey District; thence northerly by the west boundary of Sections 99 and 98, both in Huirangi Registration District, Block XI, Paritutu Survey District. and north-east by the northern boundary of said Section 98 produced to the east side of Wortley Road; thence northerly, north-easterly, and southerly by the west, north, and east boundaries of Section 111, Huirangi Registration District, Block XI, Paritutu Survey District, to the north-west corner of Section 120, Huirangi Registration District, Block XIII, Waitara Survey District; thence north-easterly along the north boundary of said Section 120 produced to the east side of Richmond Road; thence northerly along the west boundary of Sections 130 and 129, both in Huirangi Registration District, Block XIII, Waitara Survey District, to the north-west corner of said section 129; thence easterly by the north boundary of said Section 129, and southerly along the east boundaries of Sections 129, 130, 131, 132, and 133, all in Huirangi Registration District, and Block XIII, Waitara Survey District, to the north-west corner of Section 1, Block XIII, Waitara Survey District; thence north-east along the northern boundary of said Section 1 to its intersection with the west boundary of Section 208, Huirangi Registration District; thence northerly along the western boundaries of Sections 208, 149, 150, and 151, all in Huirangi Registration District and Block XIII, Waitara Survey District; thence generally easterly along the northern boundary of Block XIII, Waitara Survey District, to a point in the north side of the Roddy Road in line with the east boundary of Section 164, Huirangi Registration District, Block XIII, Waitara Survey District; thence southerly to the north-

east corner of said Section 164 and southerly along the east boundaries of Sections 164, 165, and 166, all in Huirangi Registration District, Block XIII, Waitara Survey District, to the Mangapoto Stream; thence north-east along the Mangapoto Stream to the Manganui Stream; thence along the middle of the Manganui Stream to its confluence with the Waitara River; thence south-easterly along the Clifton County boundary to Stratford County boundary; thence southerly and westerly along the Stratford County boundary to east side of the Mana Road; thence southerly along the Mana Road to its junction with the Makara Road ; thence south-westerly, crossing the Mana Road and following the southern boundary of the Makara Road to its intersection with the east boundary of Section 5, Block XI, Huiroa Survey District; thence south along east boundary of said Section 5 to its southernmost intersection with the Makino Stream; thence westerly along the Makino Stream to the west boundary of said section 5, thence northerly along the west boundary of said section 5 to the south-east corner of Section 28, Block X, Huiroa Survey District; thence westerly along the southern boundary of the said Section 28 produced to the west side of the Makara Road; thence northerly, westerly, and southerly along the east, north, and west boundaries of Section 26, Block X, Huiroa Survey District, to the southern boundary of section 20, Block X, Huiroa Survey District; thence westerly along the southern boundary produced of the said Section 20 to the west side of the Mangaotea Road; thence northerly along the west side of the Mangaotea Road to the south-east corner of Section 14, Block X, Huiroa Survey District; thence westerly along the southern boundary of the said Section 14 to its intersection with the eastern boundary of Section 11, Block X, Huiroa Survey District; thence southerly along the eastern boundary of the said Section 11 to the Croydon Road; thence westerly along the north side of the Croydon Road to the block boundary between Blocks IX and X, Huiroa Survey District; thence north following the said block-line to the Stratford County boundary; thence generally south-westerly along the boundary of Stratford County to the summit of Mount Egmont, the point of commencement : excluding the Borough of Inglewood.

### SECOND SCHEDULE.

ALL that area above described in the First Schedule, with the exception of that part of Stratford County more particularly described below, is part of Taranaki County as at present constituted.

#### BOUNDARIES OF PART OF STRATFORD COUNTY REFERRED TO ABOVE.

Commencing at the point where the Stratford County boundary meets the eastern side of the Mana Road ; thence southerly along the Mana Road to its junction with the Makara Road : thence south-westerly, crossing the Mana Road and following the southern boundary of the Makara Road to its intersection with the east boundary of Section 5, Block XI, Huiroa Survey District; thence south along east boundary of said Section 5 to its southernmost intersection with the Makino Stream; thence westerly along the Makino Stream to the west boundary of said Section 5; thence northerly along the west boundary of said Section 5; thence northerly along the west boundary of said Section 5 to the south-east corner of Section 28, Block X, Huiroa Survey District; thence westerly along the southern boundary of the said Section 28 produced to the west side of the Makara Road; thence northerly, westerly, and southerly along the east, with an analysis of Section 28, Block X, Huiroa Survey District; the southerly along the east, of the Makara Road; thence northerly, westerly, and southerly along the east, north, and west boundaries of Section 26, Block X, Huiroa Survey District, to the southern boundary of Section 20, Block X, Huiroa Survey District; thence westerly along the southern boundary produced of the said Section 20 to the west side of the Mangaotea Road; thence northerly along the west side of the Mangaotea Road to the south-east corner of Section 14, Block X, Huiroa Survey District; thence westerly along the southern boundary of the said Section 14 to its intersection with the eastern boundary of Section 11, Block X, Huiroa Survey District; thence southerly along the eastern boundary of the said Section 11 to the Croydon Road; thence westerly along the north side of the Croydon Road to the block-boundary between Blocks IX and X, Huiroa Survey District; thence north following the said block-line to the Stratford County boundary; thence east generally along the said Stratford County boundary to the point of commencement.
