An Act to amend the Inspection of Machinery Act, 1908.

Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows :—

1. (1) This Act may be cited as the Inspection of Machinery Short Title and Amendment Act, 1927, and shall be read together with and deemed part of the Inspection of Machinery Act, 1908 (hereinafter referred to as the principal Act).

(2) This Act shall come into operation on the first day of April, nineteen hundred and twenty-eight.

2. (1) The Governor-General may, from time to time, by Order in Council, make regulations for all or any of the following purposes:

(a) Providing for the registration by the Minister of designs and specifications of boilers, lifts, and cranes, and for the approval by the Minister, or an officer of the Marine Department authorized by him in that behalf, of working-l cranes.

Governor-General in Council may make regulations providing for the registration of designs and specifications of boilers, lifts, and

drawings and working-specifications of every such boiler, lift, or crane proposed to be made in accordance with a registered

design and specifications:

(b) Prescribing forms of registers and of applications for registration of designs and specifications and for approval of working-drawings and specifications, forms of certificates of registration or approval, and such other forms as may be deemed necessary for the purposes of such regulations:

(c) Prescribing what drawings and specifications shall be submitted to the Minister with or in connection with applica-

(d) Conferring on the Minister power to withhold registration or approval in any case until such alterations or modifications as he may require are made in any design, drawings, or specifications, as the case may be, or until such further or other designs, drawings, or specifications as he thinks fit are submitted to him, and power to refuse registration or approval in any case where he considers that a boiler, lift, or crane made according to the submitted design or specifications could not 20 be worked with safety:

(e) Prescribing fees for the examination of designs, drawings, and specifications of boilers, whether or not they are approved, and for the issue of certificates of registration of designs and specifications, and of approval of working-drawings and

specifications:

(f) Regulating the manufacture, erection, installation, use, maintenance, and repair of boilers, lifts, and cranes, and prohibiting the use thereof in New Zealand, unless made in accordance with registered designs and specifications and approved working-drawings and specifications:

(g) Making special provision with respect to the registration of designs and specifications of boilers, lifts, and cranes im-

ported into New Zealand:

(h) Exempting any particular kind or kinds or class or classes of boilers, lifts, and cranes from the requirements of any or all of the provisions of regulations made under this section:

(i) Prescribing fines not exceeding fifty pounds for the breach

of any such regulation.

(2) All regulations made under this section shall be published in 40 the Gazette.

(3) Any such regulations may apply generally throughout New Zealand or within any specified part or parts thereof, and may from time to time be applied by the Minister, by notice in the Gazette, to any part of New Zealand, and any such notice may at any time be in like manner altered or revoked.

(4) The operation of any regulations published as aforesaid may, if so provided therein, be wholly suspended until they are applied by the Minister by notice pursuant to the last preceding subsection.

(5) All regulations under this section shall be laid before both Houses of Parliament within fourteen days after the gazetting thereof if Parliament is then in session, and, if not, then within fourteen days after the commencement of the next ensuing session.

(a) Any machinery driven by manual or animal power; or

(b) Any machinery the motive power of which does not exceed one horse-power; or

(c) Any boiler or machinery which is declared by the Governor-General by Order in Council in that behalf not to be subject to the provisions of the principal Act.

(3) Any Order in Council under paragraph (c) of the last preceding subsection may apply generally to any particular class of boilers or 50 machinery irrespective of the purpose for which they are used, or to such boilers or machinery only while used exclusively for any specified purpose or purposes.

Provided that the Minister may at any time, on being satisfied that no attendant is necessary for the safe working of any particular class of lifts, exempt, by notice in the *Gazette*, that class of lifts from the requirements of this subsection, and any exemption so granted may, 25 by a like notice, be at any time withdrawn.

(5) In the case of a breach of any of the provisions of this section, the owner of the machinery shall be liable to a fine not exceeding twenty ounds and not less than five pounds.

6. (1) Where any machinery subject to the provisions of this Act, or any appliance or contrivance connected or used with such machinery or any part thereof, is, or appears to an Inspector, by reason of any fault 35 or defect therein or of insufficient fencing or guarding thereof, to be so dangerous as to be likely to cause loss of life or bodily injury to any person, he may give to the owner of such machinery a notice to that a effect.

(2) Such notice shall specify the fault or defect required to be 40 mess of remedied, or the guarding or fencing required to be provided, and may either require the owner—

(a) To desist from working or using such machinery or any appliance or contrivance used or connected therewith until the requirements of the Inspector as specified in such notice 45 have been complied with; or

(b) To have such machinery, appliance, or contrivance altered, or fenced, or guarded, or the faulty or defective part renewed or repaired within a certain time to be stated in such notice.

(3) The owner shall sign a duplicate copy of such notice in 50 acknowledgment of his having received it.

(4) If the owner does not comply with the terms of such notice he shall be liable to a fine of not less than *ten* pounds.

(3) It shall not be lawful for any person to do any act likely to 40 prevent the discovery of the cause of the explosion or accident until the Inspector has visited the scene thereof and completed his inquiry:

Provided that nothing in this subsection shall prohibit the owner from doing anything reasonably necessary to prevent further damage or injury to any person or property or from disconnecting a boiler 45 from others connected with it.

- (4) Every person commits an offence and is liable on summary conviction to a fine of not less than ten pounds who-
 - (a) Fails to give the notice required by subsection one hereof; or,
 - (b) Except as authorized in the proviso to the last preceding subsection, does or causes to be done any act likely to prevent the discovery of the cause of the explosion or accident.

"(6) A second-class engine-driver's certificate shall entitle the holder thereof to drive and have charge of any steam stationary engine the area of cylinder or combined area of cylinders of which does not exceed two hundred circular inches, and of its boilers.

"(7) A certificate of any grade shall entitle the holder thereof to

have charge of any boiler to which no machinery is attached.

"(8) Nothing in this section shall apply to an engine the area of cylinder or combined area of cylinders of which does not exceed one hundred and forty-four circular inches, or a boiler of fifteen horse-power or under, or to any engine or boiler forming part of the propelling machinery of any ship.

(4) In the absence of the Chief Inspector of Machinery from any meeting of the Board, the Inspecting Engineer of the Mines Department shall be the Chairman of the Board for that meeting; and in the absence of both the Chief Inspector and the Inspecting Engineer from any such meeting, such one of the additional members of the Board as the Minister may select shall be the Chairman of the Board for that meeting.

(5) All applications for examination shall be forwarded to the

Secretary, accompanied by the prescribed fee.

(6) Every applicant for examination for a certificate in respect of any winding machinery by means of which persons are drawn up or lowered down any shaft, pit, or inclined plane, or drawn along any level in any mine or coal-mine, or by means of which material is raised or lowered in the sinking of a shaft in a mine or coal-mine, shall be at least twenty-one years of age, be possessed of or entitled to such other certificate under this Act, and have had such experience as assistant to a certificated engine-driver in charge of winding machinery, as may be prescribed, and shall, in addition to the prescribed fee, forward such proof of such experience as aforesaid as may be prescribed.

(7) On an applicant passing the prescribed examination, the Secretary, on the recommendation of the Board and on being satisfied that the provisions of the principal Act and this Act have been complied with, shall issue a certificate of the appropriate grade, and, in the case of a person in charge of winding-machinery as aforesaid, such certificate shall state on the face of it whether it is granted in respect of steam

winding machinery or hydraulic winding machinery.
