

INCOME TAX AMENDMENT BILL (NO. 2)

EXPLANATORY NOTE

THIS Bill amends the Income Tax Act 1976.

Clause 1 relates to the Short Title.

Clause 2: Subclause (1) amends section 125 of the principal Act which provides for a 100 percent deduction for certain capital expenditure incurred in the carrying on of any business in New Zealand for the purposes of energy conservation.

This amendment provides for a deduction for a new motorcar equipped to use compressed natural gas and acquired on or after 1 January 1981. The deduction is to be \$1,000 where not more than one storage cylinder is incorporated in the vehicle and \$1,400 where more than one is incorporated.

Subclauses (2) and (3) make consequential amendments to section 110 of the principal Act, which provide for an upper limit for the amount on which the depreciation may be claimed in respect of motorcars, to take into account any amount which has been allowed as a deduction under section 125.

Clause 3 substitutes a new scale of tax rates for the 1980/81 income year, taking into account the combined effect of the present scale and the new scale to apply from the 1981/82 income year.

Clause 4 substitutes the new scale of tax rates to apply from the 1981/82 income year.

Clause 5 substitutes new tables for basic tax deductions. The new tables are to apply with respect to every tax deduction from payments of salaries and wages made in respect of any period ending on or after 1 February 1981.

Clause 6 inserts a new Horowhenua area in the Sixth Schedule to the Act for the purposes of regional investment allowance.

A BILL INTITLED

An Act to amend the Income Tax Act 1976

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same,
5 as follows:

1. **Short Title**—This Act may be cited as the Income Tax Amendment Act (No. 2) 1980, and shall be read together with and deemed part of the Income Tax Act 1976* (hereinafter referred to as the principal Act).
- 10 **2. Certain expenditure relating to energy conservation**—
(1) Section 125 of the principal Act (as substituted by section 21 of the Income Tax Amendment Act (No. 2) 1977) is hereby amended by inserting in the definition of the expression “qualifying expenditure” in subsection (1) (as substituted by section 28 of the Income Tax Amendment Act 1978 and amended by section 57 of the Income Tax Amendment Act 1979), after paragraph (e), the following paragraph:
“(f) Any expenditure of a capital nature incurred, on or after the 1st day of January 1981, in the carrying

on by any taxpayer of any business in New Zealand, in the acquisition of a new road vehicle (being a motorcar within the meaning of section 2 (1) of the Transport Act 1962), in the manufacture and assembling of which there has been incorporated equipment which enables that road vehicle to burn and be powered by compressed natural gas indigenous to New Zealand:

“Provided that in no case shall the amount of expenditure which is qualifying expenditure under this paragraph exceed—

“(i) Where that equipment includes not more than one storage cylinder for the storage in that road vehicle of such compressed natural gas, \$1,000;

“(ii) Where that equipment includes more than one storage cylinder for the storage in that road vehicle of such compressed natural gas, \$1,400.”.

(2) Section 110 (1) of the principal Act is hereby amended by inserting, before the definition of the expression “motor-car”, the following definition:

“‘Expenditure’, in relation to the acquisition of a motorcar by a taxpayer in any income year, means the amount of the capital expenditure incurred by that taxpayer in the acquisition of that motorcar, reduced by the amount (if any) that, in relation to that motorcar, is,—

“(a) For the purposes of section 125 of this Act, qualifying expenditure of the kind referred to in paragraph (f) of the definition of the expression ‘qualifying expenditure’ in subsection (1) of that section; and

“(b) Allowed as a deduction, pursuant to section 125 (2) of this Act, in calculating the assessable income derived by that taxpayer in that income year.”.

(3) Section 110 (6) of the principal Act (as amended by section 23 (1) of the Income Tax Amendment Act 1978) is hereby amended by repealing paragraph (a), and substituting the following paragraph:

“(a) The expenditure incurred in the acquisition of the replacement motorcar.”.

3. Basic rates of income tax for individuals and certain other taxpayers for income year that commenced on 1 April 1980—(1) In respect of the tax on income derived in the income year that commenced on the 1st day of April 1980, the principal Act shall be deemed to have effect as if the First

Schedule thereto had been amended by repealing Part B, and substituting the new Part B set out in the First Schedule to this Act.

- 5 (2) The Income Tax (Annual) Act 1980 is hereby amended by inserting in section 2, after the words "the Income Tax Amendment Act (No. 2) 1979", the words "and section 3 (1) of the Income Tax Amendment Act (No. 2) 1980".

- 10 **4. Basic rates of income tax for individuals and certain other taxpayers for income year commencing on 1 April 1981 and subsequent income years**—(1) The First Schedule to the principal Act is hereby amended by repealing Part B (as substituted by section 2 (1) of the Income Tax Amendment Act (No. 2) 1979), and substituting the new Part B set out in the Second Schedule to this Act.

- 15 (2) The Income Tax Amendment Act (No. 2) 1979 is hereby consequentially amended by repealing section 2 and the First Schedule thereto.

- 20 (3) This section shall come into force on the 1st day of April 1981, and shall apply with respect to the tax on income derived in the income year commencing on that date and in every subsequent year.

- 25 **5. Basic tax deductions**—(1) The Second Schedule to the principal Act (as substituted by section 45 (1) of the Income Tax Amendment Act (No. 2) 1977) is hereby amended by omitting the expression "\$350" (as substituted by section 3 (2) of the Income Tax Amendment Act (No. 2) 1979) in both places where it occurs, and substituting in each case the expression "\$387".

- 30 (2) The Second Schedule to the principal Act (as so substituted) is hereby further amended by repealing Appendix A (as substituted by section 3 (1) of the Income Tax Amendment Act (No. 2) 1979), and substituting the new Appendix A set out in the Third Schedule to this Act.

- 35 (3) The Income Tax Act (No. 2) 1979 is hereby consequentially repealed.

(4) This section shall apply with respect to every tax deduction from payments of salaries and wages for every pay period ending on or after the 1st day of February 1981.

- 40 **6. Regional investment allowance**—(1) The Sixth Schedule to the principal Act is hereby amended by inserting, after the item relating to the Wanganui regional development priority area, the following item:

45 "Horowhenua area: comprising the county of Horowhenua and the boroughs of Levin, Otaki, and Kapiti |

15".

(2) The Sixth Schedule to the principal Act is hereby consequentially amended—

- (a) By omitting from the item relating to the Manawatu area the words "and Horowhenua (excluding the Waikanae community of Horowhenua)":
 (b) By omitting from the item relating to the Wellington area the words "and the Waikanae community of Horowhenua County".

(3) This section shall apply to plant or machinery (being plant or machinery to which section 119 of the principal Act applies) that was acquired, installed, extended, or leased on or after the 1st day of April 1981.
