A BILL INTITULED

AN ACT to amend the Licensing Act, 1908.

Title.

BE IT ENACTED by the General Assembly of New Zealand
 in Parliament assembled, and by the authority of the same, as
 5 follows :—

1. This Act may be cited as the Licensing Act Amendment
 Act, 1909, and it shall form part of and be read together with the
 Licensing Act, 1908 (hereinafter referred to as the said Act).

Short Title.

2. (1.) From and after the passing of this Act it shall not be
 10 lawful to grant or renew any license of any description to take effect
 within the area included in the boundaries set forth in the Schedule
 hereto.

No licenses to exist within the scheduled area

(2.) The provisions of section two hundred and seventy-three of
 the said Act shall extend and apply to the whole of the said area in
 15 the same manner as if that area had been proclaimed under
 section two hundred and seventy-two.

SCHEDULE.

Schedule.

ALL that area in the Auckland, Taranaki, and Wellington Land Districts bounded
 towards the north-west by Te Wharauoa Block from the Aotea Harbour to the
 Waitetuna River: thence towards the north-west generally by the said Waitetuna
 River to its intersection by a right line running from Mount Tahuanui over
 the Teriki Range where the Native track crosses the latter; thence by the said
 right line to Mount Tahuanui; thence by a right line to Mount Pirongia; thence
 by the confiscation boundary-line to and across the Waipa River to the Puniu
 River; thence by the latter river and again by the confiscation boundary-line to the
 Waikato River; thence by the said Waikato River to the Tatua West block: thence
 towards the east by that block and Whangamata Block to Lake Taupo; thence by
 a right line across that lake to the mouth of the Tauranga River, and by that river
 to its source in the Kaimanawa Range: thence towards the south-east and south by
 the summit of that range, and the summits of the watersheds between the sources
 of the Rivers Moawhango and Waikato, and Waikato and Wangaehu, to Ruapehu
 Mountain: thence again towards the north-east and towards the south-east by a
 straight line to the source of the Wangaehu River; and thence by that river to the

Heao Block : thence towards the south-west and again towards the south-east by the said Heao Block and the Paratieke Block and the northern boundary-line of the latter block produced across the Mangawhero River ; thence by the said Mangawhero River to its confluence with the Mungakowai Stream : thence again towards the south-west by that stream to the north-western corner of the Ohineiti Block : thence towards the south by a line being the production of the northern boundary-line of the last-mentioned block to the Karewarewa Block ; and thence by that block to Te Komai Trig. Station : thence towards the south-east by the said Karewarewa Block and the Parihouhou and the Aratowaka Blocks : again towards the south-west by the Pukenui Block to the Wanganui River ; thence across that river and towards the east and south generally by the said Wanganui River to its confluence with the Kauarapaoa River : thence again towards the south-west generally by the last-mentioned river to the Kauarapaoa Block ; thence by that block, the Manganui-o-tahu Block, the Mangapapa Blocks Nos. 1b and 1c, the Mangaporau Block, the Mangapapa Block No. 2, the Kaitangiwhenua Block, and the Mangaotuku Block, to the Pohokura Block : thence towards the north-west by the said Pohokura Block to its eastern-most corner ; thence by a straight line to the confluence of the Tangarakau River with the Wanganui River ; and thence by the latter river to the Aotea Block aforesaid : thence towards the south-west and south generally by the south-western boundary-lines of the Okahukura and the Aotea Blocks respectively to the Taranaki confiscation boundary-line, and thence by that boundary-line to the ocean ; and thence towards the west and again towards the north-west by the sea : excepting from the above-described area all that parcel of land bounded towards the north-west by Lake Taupo from the mouth of the Tokaanu River to a point due north of Manganamu Mountain ; thence towards the east by a right line to that mountain ; thence towards the south by a right line running due west to the Tokaanu River ; and thence towards the west by that river to the commencing-point.
