A BILL INTITULED

AN ACT to make certain Amendments in the Law.

BE IT ENACTED by the General Assembly of New Zealand Title. in Parliament assembled, and by the authority of the same, as

1. The Short Title of this Act is "The Law Amendment Act, Short Title. 1901."

When in any action or other proceeding relating to land it appears to the Court that the defendant or any predecessor 15 in title has, in the erection of a building upon any land adjoining the land in question, encroached upon such last-mentioned land, and it does not appear to the Court that such encroachment was intentional or arose from gross negligence, then the Court, instead of ordering the defendant to give up possession of the piece of land so encroached 20 upon, or to pay damages, or instead of granting an injunction, may give the defendant the right of retaining possession of the piece of land so built upon, subject to the payment of such sum or sums of money, and to such other conditions, as to the Court shall appear just. 25

(2.) The jurisdiction conferred upon the Court by the preceding subsection hereof shall extend to and may be exercised by any Court constituted under the provisions of "The District Courts Act, 1858," or "The Magistrates' Courts Act, 1893": Provided that a defendant intending to invoke the powers hereby given to such Courts shall **30** give notice of such intention to the other party before the hearing, and the plaintiff shall thereupon be entitled, as of right, to have the action removed into the Supreme Court, or to appeal to the Supreme Court against any such order purporting to be made by the District or Magistrate's Court under this section. Any order made under **35** this section shall thereupon be transmitted by the Court to the District Land Registrar, or Registrar of Deeds, as the case may be, for registration.

VOLUNTARY CONVEYANCES.

9. (1.) Subject as hereinafter mentioned, no voluntary con-40 veyance of any lands, tenements, or hereditaments, whether made before or after the passing of this Act, if in fact made *bona fide* and without any fraudulent intent, shall hereafter be deemed fraudulent or covinous within the meaning of the Act Twenty-seven Elizabeth, Chapter Four, by reason of any subsequent purchase for value, or be 45 defeated under any of the provisions of the said Act of Elizabeth by a conveyance made upon any such purchase, any rule of law not-withstanding.

(2.) This section shall not apply in any case in which the author of a voluntary conveyance of any lands, tenements, or 50 hereditaments has subsequently, but before the passing of this Act, disposed of or dealt with the same lands, tenements, or hereditaments to or in favour of a purchaser for value.
