LOCAL AUTHORITIES EMPOWERING (RELIEF OF UNEMPLOYMENT) AMENDMENT BILL.

EXPLANATORY MEMORANDUM.

By the Local Authorities Empowering (Relief of Unemployment) Act, 1926, local authorities are empowered to borrow money (without having taken a poll of ratepayers) for public works undertaken in relief of unemployment. By the Local Authorities Empowering (Relief of Unemployment) Extension Act, 1927, it is provided that no moneys shall be so borrowed after 30th June, 1928. The present Bill extends the power to borrow under the principal Act for one year (that is, until 30th June, 1929).

By section four of the Imprest Sppply Act, 1927, provision was made for payment out of the Consolidated Fund of a subsidy to local authorities on amounts expended on public works in relief of unemployment. It is proposed to repeal that section and to re-enact it in the present Bill, at the same time increasing the aggregate amount of subsidies from £150,000 to £300,000.

This Public Bill originated in the House of Representatives, and, having this day passed as now printed, is transmitted to the LEGISLATIVE COUNCIL for its concurrence.

A BILL INTITULED

AN ACT to extend the Operation of the Local Authorities Empowering Title. (Relief of Unemployment) Act, 1926.

BE IT ENACTED by the General Assembly of New Zealand in 5 Parliament assembled, and by the authority of the same, as follows:-

1. This Act may be cited as the Local Authorities Empowering Short Title. (Relief of Unemployment) Amendment Act, 1928, and shall be read together with and deemed part of the Local Authorities Empowering (Relief of Unemployment) Act, 1926 (hereinafter referred to as the 10 principal Act).

2. (1) No moneys shall be borrowed under the authority of the Extension of period principal Act after the thirtieth day of June, nineteen hundred and within which local authorities may twenty-nine.

(2) For the purposes of this Act the reference in subsection three relief of 15 of section two of the principal Act to section twenty of the Finance Act, 1919, shall be construed as a reference to the corresponding provisions of the Local Government Loans Board Act, 1926.

(3) The Local Authorities Empowering (Relief of Unemployment) Repual.

Extension Act, 1927, is hereby repealed.

3. (1) Where any local authority within the meaning of the Local Authorizing Bodies' Loans Act, 1926, has, whether before or after the passing of this payment to local authorities of Act, provided work in relief of unemployment the Minister of Finance subsidies in respect may, without further appropriation than this section, pay to such local of amounts expended in relief authority, out of the Ordinary Revenue Account of the Consolidated of unemployment.

25 Fund, such amount as he thinks fit by way of subsidy on the amount

(2) The aggregate amount paid under this section and under section four of the Imprest Supply Act, 1927, shall not exceed three hundred thousand pounds.

(3) All moneys received by a local authority under this section shall be applied in relief of unemployment on such public works as may be approved for the purpose by the Minister of Public Works, and shall be so applied in accordance with such conditions (if any) as that Minister may impose.

(4) Section four of the Imprest Supply Act, 1927, is hereby

repealed:

Provided that the repeal of the said section shall not affect the authority thereby conferred on the Minister of Finance to pay subsidy on any amount which has heretofore been expended by a local authority 10 on works undertaken in relief of unemployment but in respect of which a subsidy has not heretofore been paid in accordance with the said section.
