A BILL INTITULED

An Act to provide for the Triennial Election of Licensing Com- Title. mittees.

BE IT ENACTED by the General Assembly of New Zealand in 5 Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Licensing Committees Short Title.

Election Act, 1887." 2. The words "the said Act," wherever in this Act occurring, Interpretation.

mean "The Licensing Act, 1881." 3. The following provisions relating to the election of Licensing Elections to be Committees, and to the taking of the poll of ratepayers, shall come triennial and

into operation on the passing of this Act:-(1.) The Returning Officer henceforth shall appoint the day for the taking of the poll of ratepayers, as mentioned in section forty-six of the said Act, as well as appoint the

day for the election of the Licensing Committee. (2.) Every member of a Licensing Committee elected in the year one thousand eight hundred and eighty-seven shall hold

office until the election of his successor. (3.) Every member of a Licensing Committee elected in the year one thousand eight hundred and eighty-eight, and thereafter, shall come into office on his election, and shall hold office for three years, or until the election of his successor.

(4.) In and after the year one thousand eight hundred and eightyeight the elections of Licensing Committees shall be held on the days appointed under the said Act for the taking of the poll of ratepayers, and simultaneously therewith once in every third year only.

Consequential amendments of "The Licensing Act, 1881." 4. And in accordance with the foregoing the said Act is hereby amended as follows, that is to say,—

(1.) The word "annually" in subsection one of section thirteen, and the words "and thereafter in the same month in every year" in subsection four, and the whole of subsections eight and eighteen of the said section thirteen, are hereby repealed, and the said section shall be read and construed as though the said repealed words and subsections respectively were omitted therefrom.

(2.) Section forty-six of the said Act is hereby amended by the 10 omission of the words "the Chairman of the Licensing Committee," and the insertion in lieu thereof of the words

"the Returning Officer."
