Title	2. Repealing Labour Department Act 1954 Schedule
1. Short Title and commencement	

A BILL INTITULED

An Act to (*consolidate and amend*) repeal the Labour Department Act 1954

BE IT ENACTED by the Parliament of New Zealand as follows:

- 5 **1. Short Title and commencement**—(1) This Act may be cited as the (*Department of Labour*) Labour Department Act Repeal Act 1988.

(2) This Act shall come into force on the 1st day of (*November 1988*) (*January*) June 1989.

2. Repealing Labour Department Act 1954—(1) The 5
Labour Department Act 1954 is hereby repealed.

(2) The enactments specified in the Schedule to this Act are hereby consequentially repealed.

(3) Nothing in this section affects—

(a) The continued existence of the department of State 10
existing immediately before the commencement of
the Labour Department Act 1903 and known then,
and immediately before the commencement of this
Act, as the Department of Labour; or

(b) The appointment or tenure of the chief executive, or any 15
other employee, of the Department of Labour; or

(c) The continued existence of any advisory council or
committee appointed under section 11 of the Labour
Department Act 1954.

(4) Every delegation under section 7 or section 7A of the 20
Labour Department Act 1954 that was in force immediately
before the commencement of this Act shall continue to have
effect according to its tenor as if it had been made on that
commencement under section 28 or section 41 of the State
Sector Act 1988. 25

(5) Every reference in—

(a) Any Act, regulation, or other enactment, passed, made, or
enacted before the 11th day of June 1985; or

(b) Any contract, agreement, deed, instrument, application,
licence, notice, or other document entered into, 30
made, granted, given, or executed, before the 1st day
of November 1954,—

to the Minister of Employment shall continue to be read as a
reference to the Minister of Labour.

(6) Every reference to the National Employment Service in 35
any enactment or document shall continue to be read as a
reference to the Department of Labour.

(7) Every reference to the Director of Employment in any enactment or document shall continue to be read as a reference to the Secretary of Labour.

5 (8) Every reference in—

(a) Any Act, regulation, or other enactment, passed, made, or enacted before the commencement of this Act; or

10 (b) Any contract, agreement, deed, instrument, application, licence, notice, or other document, entered into, made, granted, given, or executed, before that commencement,—

to the Secretary of Labour appointed under the Labour Department Act 1954 shall be read as a reference to the chief executive of the Department of Labour.
