A BILL INTITULED

An Act to amend the Local Elections and Polls Act, Title. 1925.

BE IT ENACTED by the General Assembly of New 5 Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the Local Elections short Title. and Polls Amendment Act, 1941, and shall be read together with and deemed part of the Local Elections See Reprint 10 and Polls Act, 1925 (hereinafter referred to as the of Statutes, vol V, p. 447 principal Act).

2. (1) Every general election of members of any local authority that is required to be held in the month of May in any year shall be held on the third Saturday in that month.

General elections of all local authorities to be held on Saturdays.

2. (1A) Every general election of members of any local authority shall be held on a Saturday.

- (1B) Every such general election that is required to be held in the month of May in any year shall be held on the third Saturday in that month.
- (2) Where, if this subsection had not been passed, any other general election of members of any local authority would have been required to be held on any day not being a Saturday, that election shall be held on the first Saturday following that day.

(3) The enactments specified in the *First* Schedule 10 to this Act are hereby amended in the manner indicated in that Schedule.

(4) The Thames Borough Commissioner Amendment Act, 1937, is hereby consequentially repealed.

- 3. (1) Notwithstanding anything to the contrary in 15 any other Act, any notice published before the passing of this Act and relating to the date of any poll to be taken during the month of May, nineteen hundred and forty-one, or of any election to be held during that month, may be withdrawn and a fresh notice may be 20 published in substitution therefor.
- (2) Upon publication of a fresh notice in accordance with this section the notice first published shall be deemed to be revoked.
- 4. Section twenty-five of the principal Act is 25 hereby amended by omitting from subsection one, as amended by section eight of the Local Elections and Polls Amendment Act, 1926, the words "striking out the name of every candidate for whom he does not desire to vote", and substituting the words "marking 30 a cross in a square set opposite to the name of each such candidate".
- 5. (1) The voting-papers to be used at any election held under Part I of the principal Act shall be in the form numbered (1) in the Second Schedule to this Act. 35
- (2) Except as provided in the next succeeding subsection, the voting-papers to be used at any poll shall be in the form numbered (2) in the Second Schedule to this Act.
- (3) The voting-papers to be used at any poll upon 40 a proposal to raise a special loan under the Local Bodies' Loans Act, 1926, shall be in the form numbered (3) in the *Second* Schedule to this Act, and shall contain full particulars of the notice required by section ten of that Act or a statement giving the purport and 45 effect of that notice:

Voting by cross to be used at all local elections and polls.

Form of voting-papers.

Provided that the voting-papers to be used at any such poll that is held before the first day of June, nineteen hundred and forty-one, may be in the same form as if this Act had not been passed.

- (4) Every voting-paper shall have a counterfoil, and shall have printed on the back thereof and on the counterfoil respectively the matter contained in the form numbered (4) in the Second Schedule to this Act.
- (5) The voting-papers to be used at any election 10 or poll shall be printed on paper of uniform colour, and where an election and a poll or two or more elections or polls are held simultaneously the votingpapers in each case shall be different in colour.

6. The enactments specified in the Third Schedule Consequential 15 to this Act are hereby consequentially repealed.

7. (1) The person who is for the time being the tenant of any dwelling leased to him under Part I of the Housing Act, 1919, shall be entitled to have his as if they were name entered on any list or roll of electors or rate-20 payers of any local authority in the same cases and in the same manner as if his name appeared in a the Vol. III, p. 798 valuation roll under the Valuation of Land Act, 1925, of the district of the local authority as the occupier of that dwelling and as if the dwelling were a separate 25 rateable property.

(2) For the purposes of any Act that prescribes different qualifications entitling persons to have their names entered on any such list or roll, every person 30 to whom the last preceding subsection relates shall be deemed to possess a rating qualification.

- (2) All Orders in Council issued under the said section eighteen before the passing of this Act are 40 hereby revoked.
- (3) The proviso to subsection one of section seventeen of the Municipal Corporations Act, 1933, and the proviso to section eleven of the Auckland Electric-power Board Amendment Act, 1937, are hereby consequentially 45 repealed.
