

## LYTTELTON HARBOUR BOARD LAND BILL.

### AMENDMENTS TO BE MOVED IN COMMITTEE.

Clause 3: Strike out all the words from "subject" to "Schedule," both inclusive, and insert in lieu thereof the words, "reserving nevertheless to the public such full and free access to and enjoyment of the land described in the said *Second* Schedule as they have heretofore enjoyed."

Clause 4: Insert the word "lease" after the word "sell," and, after the word "lands," the words "and shall not remove or deface the Cave Rock, situate on the land described in the said *Second* Schedule."

A BILL INTITULED

AN ACT to vest certain Land in the Lyttelton Harbour Board, and to enable the Board to devote the same to particular Purposes. Title.

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The Lyttelton Harbour Board Land Act, 1894." It shall be deemed to be a special Act within the meaning of "The Public Reserves Act, 1881." Short Title.

2. In this Act, if not inconsistent with the context,—  
10 "The Board" means the Lyttelton Harbour Board, constituted by "The Lyttelton Harbour Board Act, 1876." Interpretation.

3. The pieces of land described in the *First* and *Second* Schedules hereto, being land in the Sumner Survey District, Block Eleven, part of which is used as a signal-station, is hereby vested in the Board, Land vested in the Board.  
15 subject, however, to the free right to the public at all times of ingress, egress, and regress to or into and from the land described in the said *Second* Schedule; and the District Land Registrar at Christchurch is hereby authorised, directed, and empowered to issue a certificate of title to the same to the Board. Power to issue certificate of title.

4. The Board shall have no power to sell or mortgage the said lands. The Board to have no power to sell or mortgage.

FIRST SCHEDULE.

ALL that piece of land, situate in the Sumner Survey District, Block XI., containing 49 acres 1 rood 35 perches, more or less. Bounded towards the north by Rural Section No. 3954; towards the east by the road, 1 chain wide, reserved along the sea; and towards the south and west by the road, 1 chain wide, reserved along the estuary of the Avon and Heathcote Rivers: the said piece of land being known as Reserve No. 224 (in red).

SECOND SCHEDULE.

ALL that piece of land, situate in the Sumner Survey District, Block XI., containing 2 roods, more or less, and known as the Cave Rock, situate near the northern end of Rural Section No. 2: the said piece of land being known as Reserve No. 2507 (in red).
