A BILL INTITULED

**An Act to authorise the Manukau City Council to reclaim
from the sea certain land in the Manukau Harbour**

5 BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. Short Title—This Act may be cited as the Manukau City Empowering (Mangere Bridge Reclamation) Act 1971.

10 **2. Special Act**—This Act shall be deemed to be a special Act within the meaning of the Harbours Act 1950.

15 **3. Authority to reclaim land**—Notwithstanding anything contained in subsection (3) of section 175 of the Harbours Act 1950, but subject to the provisions of sections 176 to 182 of that Act, the Corporation of the City of Manukau is hereby authorised and empowered to reclaim from the sea the land described in the Schedule to this Act or any part or parts thereof.

4. Reclaimed lands to form part of Manukau City—

(1) Any land which has been reclaimed under the authority of this Act shall without further or other authority than this section be included within the district of Manukau City and the boundaries of the City shall be deemed to be altered accordingly. 5

(2) Without in any way limiting the effect of subsection (1) of this section, such altered boundary or boundaries shall from time to time on written application on behalf of the Manukau City Council and without further authority or procedure be formally recorded by notice in the *Gazette* under the hand of the Secretary for Internal Affairs. 10

5. Other powers and rights not prejudiced—(1) Nothing in this Act shall be construed as limiting the powers of the Director-General of Health or other proper officer of the Department of Health to make and issue directions and requisitions relating to materials to be used in any reclamation under the authority of this Act and method of construction, covering, protection, and maintenance of such reclamation, or in respect of any other matter authorised in the Health Act 1956 or in any other Act. 15 20

(2) Nothing in this Act shall entitle the Corporation of the City of Manukau or other person to create a nuisance or shall deprive the Auckland Harbour Board or any other person of any right of remedy it or he would otherwise have against the Corporation of the City of Manukau, or other person as the case may be, in respect of any such nuisance, or shall entitle the Corporation of the City of Manukau to carry out the work of reclamation in such a way as to cause detriment to the adjoining foreshore vested in the Auckland Harbour Board or to create a hazard to or impede navigation in the Manukau Harbour. 25 30

SCHEDULE

ALL that piece of land in the North Auckland Land District containing 68 acres 3 roods more or less bounded by a line commencing at the southernmost corner of Section 1, Block V, Otahuhu Survey District, and proceeding north-westerly along mean high water spring tide mark Manukau Harbour to and northerly along the eastern boundary of an area coloured red on S.O. plan 45047 proclaimed road by *Gazette* 1873, page 248, to and easterly and southerly along the northern and eastern boundaries of the said Section 1 to the point of commencement, but excluding thereout all the land contained in the authority to reclaim described in *Gazette* 1968, page 1234.
