- 5 WHEREAS certain errors and omissions have been found to have Preamble. occurred in the Schedules appended to "The Middle Island Half-caste Crown Grants Act, 1877," and "The Middle Island Half-caste Grants Act, 1883," and it is expedient to rectify the same :
- BE IT THEREFORE ENACTED by the General Assembly of New 10 Zealand in Parliament assembled, and by the authority of the same. as follows :---

1. The Short Title of this Act is "The Middle Island Half-caste Grants Act, 1885."

2. It shall be lawful for the Governor to execute Crown grants in 15 favour of the half-castes named in Schedule A of this Act, for the sections of land set opposite their names respectively.

3. Notwithstanding anything contained in "The Public Reserves Land set apart for Sale Act, 1878," the lands described in Schedule B of this Act shall grantees in Schedule C. be and are hereby set apart for the purpose of grants of land to the

20 half-castes named in Schedule C to this Act; and it shall be lawful for the Governor to execute Crown grants in favour of the said persons for the areas set opposite their names respectively.
