Title. 2. Repeal. 3. Land to vest in Mayor, Councillors, and Bur-gesses of Borough of Masterton. Preamble. 1. Short Title.

A BILL INTITULED

AN ACT to make Provision for the Management of the Masterton Title. Public Park.

WHEREAS under the provisions of "The Greytown and Masterton Preamble.

- 5 Park and Cemetery Reserve Management Act, 1875," part of section numbered nineteen in the Township of Masterton became and is now vested in the Masterton Park Trustees, a body corporate with perpetual succession, in trust for park purposes, as therein mentioned : And whereas the said land is comprised within the area of the
- 10 Borough of Masterton: And whereas the annual income derived from the said lands is entirely insufficient and inadequate to enable the Trustees to properly maintain, manage, and improve the same: And whereas it is desirable in the interest of the Masterton Borough and its inhabitants that the said lands should cease to
- 15 be vested in the Masterton Park Trustees, and should become vested in the Mayor, Councillors, and Burgesses of the Borough of Masterton for the purposes of and to be used as a public park and pleasuregrounds:

BE IT THEREFORE ENACTED by the General Assembly of New 20 Zealand in Parliament assembled, and by the authority of the same, as follows :---

1. The Short Title of this Act is "The Masterton Public Park Short Title. Management Act, 1901."

2. "The Greytown and Masterton Public Park and Cemetery Repeal. 25 Reserve Management Act, 1875," in so far as it relates to the Masterton Park Trustees and the land, part of section nineteen in the Township of Masterton, vested in them under the provisions thereof in trust for park purposes and a public park is hereby repealed.

- 3. On the passing of this Act, the Masterton Park Trustees as Land to vest in 30 a corporate body shall cease to exist, and be abolished, and the said Mayor, Councillors, land shall thereupon divest from them, and shall become vested in Borough of Masterthe Mayor, Councillors, and Burgesses of the Borough of Masterton ton. in trust for the purposes of public recreation and pleasure-grounds,
- 35 as provided and defined by "The Municipal Corporations Act, 1900," section three hundred and fifty-five, without any conveyance or memorandum of transfer of the same.
