# A BILL INTITULED

AN ACT to authorise the Sale or other Disposition of certain Lands Title. and Premises held as Residences for Ministers of the Crown.

- WHEREAS the lands described in the *First* Schedule hereto, to- Preamble. 5 gether with the buildings thereon and the appurtenances thereto, were acquired by the Crown, and are now held as residences for Ministers of the Crown at Wellington: And whereas the lands described in the *Second* Schedule hereto, forming portion of the lands aforesaid, were by section three of "The Public Domains Act,
- 10 1881," brought within the operation of that Act: And whereas it is expedient that the whole of the said lands and premises should be sold or otherwise disposed of in manner hereinafter provided :

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the 15 same, as follows :---

1. The Short Title of this Act is "The Ministerial Residences short Title. Sale Act, 1894."

2. The Governor may, by notification published in the Gazette, Governor may sell from time to time declare that all or any of the lands described in lands in First Schedule.

20 the *First* Schedule hereto shall be sold or disposed of under the provisions of this Act; and, upon such gazetting, the lands included in any such notification shall be sold or disposed of in the manner herein provided and not otherwise.

3. The said lands, together with the buildings thereon, shall be Manner of sale. 25 offered for sale by public auction, either as separate properties or in sections, the size and upset price of which shall be fixed and determined by the Minister for Public Works, subject to the approval of the Governor in Council:

4. Pending the sale of any of the said land and premises, it shall Power to lease 30 be lawful for the Governor to lease the same.

No such lease shall extend for a greater term than one year, and the lessee shall not have any right of compensation for improvements at the expiration of his lease.

Every such lease shall contain such covenants, stipulations, and agreements as the Governor shall determine.

5. The Governor may, in the name and on behalf of Her Majesty the Queen, execute such conveyances, transfers, leases, and instruments as may be necessary for giving effect to the provisions of this Act.

6. So much of "The Public Domains Act, 1881," and "The Public Reserves Sale Act, 1888," as deals with or purports to deal with or affect any of the lands described in the *First* Schedule hereto, is hereby repealed.
