

## MASSEY UNIVERSITY AMENDMENT BILL

---

### EXPLANATORY NOTE

THIS Bill amends the Act heretofore known as the Massey University of Manawatu Act 1963.

*Clause 1* relates to the Short Title to the Bill.

*Clause 2* changes the name of the University, which in future is to be known as Massey University.

*Clause 3* increases to £750 the amount which an employee of the University may receive from the University without ceasing to be eligible for office as a member of the University Council. At present the amount is £400.

*Clause 4* amends section 13 (2) of the principal Act, as from its commencement, so as to make it clear that the Council may, by its statutes or regulations, prescribe the manner in which elections of members of the Council shall be determined.

**A BILL INTITULED**

**An Act to amend the Massey University of Manawatu Act  
1963**

5 **BE IT ENACTED** by the General Assembly of New Zealand  
in Parliament assembled, and by the authority of the same, as  
follows:

10 **1. Short Title**—This Act may be cited as the Massey  
University Amendment Act 1966, and shall be read together  
with and deemed part of the Act heretofore known as the  
Massey University of Manawatu Act 1963\* (hereinafter  
referred to as the principal Act).

**2. Change of name of University**—(1) The principal Act  
may hereafter be cited as the Massey University Act 1963.  
15 (2) Section 1 of the principal Act is hereby consequentially  
amended by omitting from subsection (1) the words “of  
Manawatu”.

(3) The principal Act is hereby amended by omitting the words "the Massey University of Manawatu" in each place where they occur in the Title and in sections 2, 3, 6, 24, 28, 29, 30, 43, 55, and 56 and in subsections (2) and (7) of section 25, and in subsections (2), (4), and (6) of section 26, and substituting in each case the words "Massey University". 5

(4) Part II of the First Schedule to the Local Authorities (Members Contracts) Act 1954 (as amended by section 57 (1) of the Massey University Act 1963) is hereby further amended by repealing the item relating to the Council of the Massey University of Manawatu, and substituting the following item: 10

"The Council of Massey University | 1963, No. 7—The Massey University Act 1963." 15

(5) Part II of the Schedule to the Public Bodies Meetings Act 1962 (as amended by section 57 (2) of the Massey University Act 1963) is hereby further amended by repealing the item relating to the Council of the Massey University of Manawatu, and substituting the following item: 20

"The Council of Massey University | 1963, No. 7—The Massey University Act 1963." 20

(6) Section 18 of the Local Authorities Loans Act 1956 (as amended by section 59 (1) of the Universities Act 1961 and by section 57 (3) of the Massey University Act 1963) is hereby further amended by repealing subparagraph (vi) of paragraph (d), and substituting the following subparagraph: 25

"(vi) The Council of Massey University under section 50 of the Massey University Act 1963." 25

(7) The principal Act is hereby amended by repealing subsections (1) and (2) of section 57 and so much of the Second Schedule as relates to the Local Authorities Loans Act 1956. 30

(8) Every other reference in any enactment or document whatsoever to the Massey University of Manawatu Act 1963 shall hereafter be read as a reference to the Massey University Act 1963. 35

(9) Every other reference in any enactment (except the principal Act) or in any document whatsoever, to the Massey University of Manawatu (however it is described) shall, unless the context otherwise requires, hereafter be read as a reference to Massey University. 40

(10) The corporate identity of the said University shall not be affected by the passing of this Act; and the said University shall, notwithstanding the change of its name effected by this section, continue to be for all purposes the same institution with the same powers as before the passing of this Act. 45

**3. Employees as Council members**—Section 9 of the principal Act is hereby amended by omitting from the second proviso to subsection (1) the words “four hundred pounds”, and substituting the words “seven hundred and fifty pounds”.

- 5 **4. Election of Council members**—Section 13 of the principal Act is hereby amended, as from its commencement, by inserting in subsection (2), after the words “shall be conducted”, the words “and determined”.
