A BILL INTITULED

An Act to vest in the Board certain parts of the Mangonui, Bay of Islands, Tutukaka, and Whangarei Harbours and to authorise the Board to reclaim certain lands; and to exempt land in the Bay of Islands Harbour from certain provisions of the Counties Amendment Act 1961; and to bring the Parengarenga Harbour under the control of the

BE IT ENACTED by the General Assembly of New Zealand 10 in Parliament assembled, and by the authority of the same, as follows:

- 1. Short Title—This Act may be cited as the Northland Harbour Board Vesting and Empowering Act 1968.
- **2. Interpretation—**In this Act, unless the context otherwise 15 requires, the term "the Board" means the Northland Harbour Board.

- 3. Special Act—This Act shall be deemed to be a special Act within the meaning of the Harbours Act 1950.
- 4. Authority to reclaim land—The Board is hereby authorised notwithstanding anything contained in section 175 of the Harbours Act 1950, but subject to the provisions of sections 176 to 182 of that Act, to reclaim the lands described in the First, Third, Fourth, Sixth, Seventh, Eighth, Ninth, Tenth, Eleventh, and Twelfth Schedules to this Act.

- 5. Vesting—The lands described in the First, Second, Fifth, Sixth, Seventh, Eighth, and Tenth Schedules to this Act are hereby vested in the Board as an estate in fee simple in trust for harbour purposes subject nevertheless to the same reservations and restrictions as are imposed by section 59 of the Land Act 1948.
- 6. Authority to District Land Registrar to issue certificates of title—The District Land Registrar for the Land Registration District of North Auckland is hereby authorised on the deposit with him of such plans and documents as he may require, to issue to the Board, certificates of title in respect of the lands vested in the Board in pursuance of section 5 of this Act, to make such entries in the register books, and do all such things as may be necessary to give effect to the provisions of this Act.
- 7. Application of Counties Amendment Act 1961—The provisions of section 29 of the Counties Amendment Act 1961 (as amended by section 22 of the Counties Amendment Act 1964) shall not apply and shall be deemed never to have applied to the land described in the Thirteenth Schedule to this Act.
- 8. Parengarenga Harbour to be brought under control of Board—The Northland Harbour Board Act 1965 is hereby amended by adding to the harbours described in the First Schedule to that Act the following harbour:

Parengarenga Harbour—The limits of which are defined in Order in Council of 20 November 1868, *Gazette* 35 23 November 1868, p. 549.
