Title.

A BILL INTITULED

AN ACT to amend the New Plymouth Recreation and Title.
Racecourse Reserve Act, 1887.

BE IT ENACTED by the General Assembly of New
5 Zealand in Parliament assembled, and by the authority
of the same, as follows:—

1. This Act may be cited as the New Plymouth Short Title.
Recreation and Racecourse Reserve Amendment Act,
1942, and shall be read together with and deemed part
10 of the New Plymouth Recreation and Racecourse
Reserve Act, 1887 (hereinafter referred to as the
principal Act).

15 2. Section four of the principal Act is hereby
amended by adding, after paragraph five, the following
paragraph:—

“(6) The said Borough Council may from time to
time, subject to such terms and conditions as it deems
fit,—

20 “(a) Release the Taranaki Jockey Club from pay-
ment, wholly or in part, of any moneys now
due and payable or hereafter to become due
and payable by the said club pursuant to

the provisions of subsection four of section four of the principal Act, as amended by paragraph (d) of section three of the New Plymouth Recreation and Racecourse Reserve Amendment Act, 1920, and by this Act: 5

“(b) Give time to the said club for payment of the moneys mentioned in paragraph (a) hereof:

“(c) Agree with the said club for the payment by the said club of a lesser sum than that specified in subsection four of section four of the principal Act, as amended as aforesaid for such period or periods as the said Council thinks fit.” 10

Section 4 of principal Act amended.

2A. (1) Section four of the principal Act, as amended by section three of the New Plymouth Recreation and Racecourse Reserve Amendment Act, 1920, is hereby further amended as follows:— 15

(a) By omitting from paragraph four the words “One hundred pounds”, and substituting the words “Twenty-five pounds”:

(b) By adding, after paragraph five, the following paragraph:—

“(6) The said Borough Council may from time to time, subject to such terms and conditions as it deems fit,— 25

“(a) Give time to the said club for payment of any moneys payable by it under this section: 30

“(b) Agree with the said club that the Council will accept a lesser sum than that specified in paragraph four of this section in full satisfaction of the liability of the club under that paragraph in respect of such period as the Council thinks fit.” 35

(2) Section three of the New Plymouth Recreation and Racecourse Reserve Amendment Act, 1920, is hereby consequentially amended by repealing paragraph (d) thereof. 40
