A BILL INTITULED

An Act to vest certain Land in the Town of Invercargill in the Title. New River Harbour Board.

BE IT ENACTED by the General Assembly of New Zealand in 5 Parliament assembled, and by the authority of the same, as follows:—

1. The Short Title of this Act is "The New River Harbour Short Title.

Endowments Act, 1883."

2. From and after the passing of this Act the lands described in Land described in the Schedule to this Act shall vest in the New River Harbour Board Schedule vested in New River Harbour 10 and their successors, for an estate of inheritance in fee-simple, as an Board. endowment for the benefit of the New River Harbour.

3. The said lands shall and may be dealt with in all respects by Lands to be dealt the said New River Harbour Board, subject to the provisions of "The With under "The Harbours Act,

Harbours Act, 1878," and any amendment thereof.

4. The Governor may issue such Crown grants or make such Crown grants may other assurances as may be necessary for evidencing the title of the said New River Harbour Board to the said lands, and such grants or other assurances so issued may be registered under "The Land Transfer Act, 1870," or any amendment Act, anything therein con-20 tained to the contrary notwithstanding.
