## A BILL INTITULED

An Act to empower the Auckland Centre of the New Title.

Zealand Branch of the British Red Cross and Order of St. John to transfer certain Land, Debentures.

Securities, and other Assets to the New Zealand Red Cross Society.

WHEREAS the New Zealand Branch of the British Red Preamble. Cross and Order of St. John (hereinafter called the incorporated society) was on the eighteenth day of October, 10 nineteen hundred and twenty, duly incorporated under the provisions of section twelve of the War Funds Act, 1915: And whereas by rule three of the rules of the said incorporated society provision was made for the constitution of centres in each of the four military districts of New Zealand—namely, Auckland, Wellington, Canterbury, and Otago—and that each centre should control and administer or dispose of its own district funds and assets subject to the approval of the executive committee:

And whereas a centre of the incorporated society was duly constituted in Auckland and acquired as its own property (a) the land described in the First Schedule hereto the title to which is vested in the incorporated society, but in trust for the Auckland Centre; (b) the debentures, securities, and other assets mentioned in the Second Schedule hereto which are now held and controlled by the said centre: And whereas the New Zealand Red Cross Society, Incorporated (hereinafter called the Red Cross Society), was on the twenty second day of December, 10 nineteen hundred and thirty-one, duly incorporated under the provisions of the Incorporated Societies Act, 1908, and it has been agreed with the approval of the executive committee of the incorporated society that the Auckland Centre of the incorporated society should transfer to 15 the Red Cross Society the property and assets above mentioned to be held by the Red Cross Society upon the trusts and for the purposes upon and for which the said Auckland Centre has heretofore held the same: And whereas it is desirable to authorize the said transfer and 20 to make certain further provision in reference to the premises:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the New Zealand Branch of the British Red Cross and Order of St. John Empowering Act, 1933.

Incorporated society authorized to transfer assets to Red Cross Society.

Short Title.

2. Notwithstanding anything contained in the War Funds Act, 1915, or in any other Act, or in the consti- 30 tution of the Red Cross Society, the Auckland Centre of the incorporated society and the incorporated society may transfer to the Red Cross Society the land, debentures, securities, and assets set out in the Schedules hereunder. to be held by the Red Cross Society upon trust for the 35 purposes for which the same were heretofore held by the Auckland Centre of the incorporated society, and to be administered, controlled, and disposed of for such purposes by a committee one-half of whose members are to be appointed by the Auckland Centre of the Red Cross 40 Society and the other half by the Auckland Centre of the St. John Ambulance Association; and the Red Cross Society is hereby authorized and empowered to accept and hold the same accordingly.

3. Any gifts, bequests, or legacies made or given to Gifts, bequests, the Auckland Centre of the incorporated society and all assets and property otherwise coming or belonging to the Cross Society. said centre shall vest in the Red Cross Society and be held 5 by it upon the trusts and for the purposes set out in this Act, and be administered, controlled, and disposed of by the committee referred to in the last preceding section.
