Title	2. Improper use of words implying membership of the New Zealand Register of Osteopaths Incorporated
1. Short Title	

A BILL INTITULED

An Act to prohibit the improper use of any description implying membership of the New Zealand Register of Osteopaths Incorporated

5 BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, as follows:

1. **Short Title**—This Act may be cited as the New Zealand Register of Osteopaths Incorporated Act 1978.

10 **2. Improper use of words implying membership of the New Zealand Register of Osteopaths Incorporated**—

(1) Every person commits an offence against this Act who, not being a member of the New Zealand Register of Osteopaths Incorporated, uses or permits to be used any written
15 words, title, or initials, in relation to himself, that are calculated to imply that he is a member of that body.

(2) Every person who commits an offence against this Act is liable on summary conviction to a fine not exceeding \$200.

A BILL INTITULED

An Act to amend the North Shore Drainage Act 1963

BE IT ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same,
5 as follows:

1. Short Title—This Act may be cited as the North Shore Drainage Amendment Act 1977, and shall be read together with and deemed part of the North Shore Drainage Act 1963 (hereinafter referred to as the principal Act).
- 10 2. Voting powers of members—The principal Act is hereby amended:
- (a) By repealing the proviso to section 15 (1);
 - (b) By repealing paragraphs (a), (b), (c) and (d) of section 15 (1).
- 15 3. Appointment of officers—Section 21 (1) of the principal Act is hereby amended by deleting the words “Secretary/Manager” and substituting the word “Manager”.
