Title. Preamble. 1. Short Title. 2. Empowering Governor to grant certain land to Otago Dock Trust. Schedule.

A BILL INTITULED

An Act to empower the Governor to grant to the Otago Dock Title. Trust certain Land originally reserved for Railway Purposes out of an Endowment for the Graving-dock at Port Chalmers.

5 WHEREAS by section seven of "The Special Powers and Contracts Preamble. Act, 1884," the Governor was empowered to grant to the Otago Harbour Board the land mentioned and described in the said section of the aforesaid Act, on condition, inter alia, that out of the land to be so granted the Governor might, on behalf of the Queen, set

- 10 apart and reserve for the use of Her Majesty such portion of the said land as he might think fit for any public work within the meaning of "The Public Works Act, 1882:" And whereas in pursuance of the powers and authorities above mentioned the Governor granted the said land to the Otago Harbour Board, reserving through
- 15 the said land a strip of land two hundred and fifty links wide for the purposes of the public work known as the Dunedin and Port Chalmers Railway: And whereas under "The Otago Dock Act 1883 Amendment Act, 1885," a trust in substitution of the Otago Harbour Board was created by the name of "The Otago Dock Trust," in
- 20 whom, under the authority of the same Act, is now vested the land herein-above mentioned as having been granted to the Otago Harbour Board: And whereas the area of land reserved for the Dunedin and Port Chalmers Railway as aforesaid is in excess of what is now required for the purposes of the said railway, and it is desirable to
- 25 grant to the aforesaid Otago Dock Trust the portion of the said land not so required: And whereas the said last-mentioned land is vested in Her Majesty:

BE IT THEREFORE ENACTED by the General Assembly of New Zealand in Parliament assembled, and by the authority of the same, 30 as follows:—

- 1. The Short Title of this Act is "The Otago Dock Land Act, Short Title. 1888."
- 2. The Governor may, in the name and on behalf of the Queen, Empowering grant to the herein-above mentioned Otago Dock Trust the land Governor to 35 mentioned and described in the Schedule hereto as an endowment for the graving-dock at Port Chalmers.

SCHEDULE.

ALL that parcel of land situate partly in the Borough of Port Chalmers, partly in Section 62, Sawyer's Bay Survey District, and partly in reclaimed land, Mussel Bay, being a strip of land 50 links in width and of an average length of 1,600 links, adjoining the north side of, and parallel to, the fence, which bounds towards the north-west the land occupied by the railway in Mussel Bay, comprising an area of 3 roods 7 perches or thereby, all in the Provincial District of Otago: as the same is delineated on the plan marked M.D. 1415, deposited in the office of the Minister for Public Works, at Wellington, and thereon coloured red, yellow, and blue.
