Otago Education Reserves Abandonment.

A BILL INTITULED

An Act to release certain Lands in the Province of Title. Otago heretofore reserved from Sale and set aside for and appropriated to Educational Purposes from the Reserves affecting the same.

WHEREAS by an Ordinance of the Superintendent and Provincial Preamble. Council of the Province of Otago passed in the nineteenth Session thereof number one hundred and eighty-four and shortly entitled "The Education Reserves Ordinance 1864" the lands particu-5 larly specified in the First Schedule hereto were with other lands reserved from sale and set aside for and appropriated to the establishment and maintenance of a University in the City of Dunedin in the said Province and of Public Schools in different parts of the Province and for the general advancement of education in the said Province: 10 And whereas the lands particularly specified in the Second Schedule

hereto were upon the recommendation of the said Provincial Council reserved from sale by the Superintendent under the provisions of the sixty-second section of "The Otago Waste Lands Act 1866" and set aside and appropriated to the establishment and maintenance of a 15 University in the said City of Dunedin and of Public Schools in

different parts of the Province and for the general advancement of education in the said Province: And whereas no grant from the Crown has yet been issued for the said lands or any of them or any part thereof respectively: And whereas the said Provincial Council has 20 passed a resolution to the effect that the said lands are no longer required for the purposes for which they were reserved and it is expedient that the said lands so reserved as aforesaid should be

relinquished and abandoned: BE IT THEREFORE ENACTED by the General Assembly of New 25 Zealand in Parliament assembled and by the authority of the same as

1. The Short Title of this Act shall be "The Otago Education Short Title. Reserves Abandonment Act 1871."

2. "The Otago Education Reserves Ordinance 1864" in so far but Lands specified in 30 so far only as the same reserves from sale or purports to reserve from sale and to set aside for and appropriate to the establishment and under "The Otago maintenance of a University in the City of Dunedin and of Public Ordinance 1864."

Schools in the Province of Otago and for the general advancement of Ordinance 1864." education in the said Province the lands specified in the First Schedule

35 hereto shall be and the same is hereby repealed.

Land specified in Second Schedule to from sale.

3. The land specified in the Second Schedule hereto shall no second schedule to be no longer reserved longer be reserved from sale and set aside and appropriated to the establishment and maintenance of a University in the City of Dunedin nor of Public Schools in the said Province nor for the general advancement of education in the said Province notwithstanding the said 5 recommendation of the Provincial Council and the reserve made by the Superintendent upon such recommendation or any other matter or thing whatsoever done in respect thereof.

Land in First Schedule no longer subject to "The Otago Education Reserves Management and Leasing Ordinace 1864."

4. The lands specified in the First Schedule hereto shall be no longer subject to the provisions of "The Otago Education Reserves 10 Management and Leasing Ordinance 1864" or any other Ordinance affecting the same as Educational Reserves: And in so far but so far only as the said recited Ordinance or any other Ordinance relate to or affect the said lands as Educational Reserves the same shall be and are hereby repealed.
